Re: 2025 Fiscal Year Nonprofit Grant Application

New Jersey Conservation Foundation Lamington Conservancy Phillipsburg Riverview Organization Ridge & Valley Conservancy South Jersey Land Trust County Agriculture Development Boards Municipal Agriculture Advisory Committees

Enclosed is a copy of the Notice of Availability of Grant Funds and Application Deadline for the FY2025 Farmland Preservation, Nonprofit Acquisition Grant program. We have requested this notice be published in the New Jersey Register on or before **December 4, 2023**.

Applications may be submitted for <u>individual farms</u> up until the June 15, 2024 deadline, although we would encourage all participants to submit applications earlier if possible. Early submissions will allow State Agriculture Development Committee (SADC) staff to proceed with evaluations, site visits and funding need estimates earlier for future appropriation requests.

We anticipate awarding grants based on need after evaluating the individual farm applications submitted and past grant expenditure performance (if applicable). As with other Nonprofit rounds, if you are submitting more than one individual farm application the SADC must prioritize them in order of quality score order pursuant to N.J.A.C. 2:76-12.2 (b). Please let us know if your agency's application prioritization is different than the quality score.

In order to provide maximum flexibility to nonprofits submitting more than one individual application, please group individual farm applications in two tiers.

#### 1. Tier 1

The individual applications that have a quality score (as determined by N.J.A.C. 2:76-6.16) greater than or equal to 70% of the county average quality score as determined in the County Planning Incentive Grant (PIG) program (enclosed). The nonprofit may process these applications in any order. With this spending structure, nonprofits have the ability to pursue any approved application provided the application meets the quality score requirement.

#### 2. Tier 2

Individual applications that do not meet the above quality score requirement would be processed in rank order. Prior to moving down the list of farms in this tier, the nonprofit must demonstrate that the higher-ranked applications within its Tier 2 list are not active at that time, and detail that efforts made to preserve all applications in Tier 1 did not result in an active application.

Please note that all farmland preservation applications must meet the minimum eligibility criteria set forth in N.J.A.C. 2:76-6.20. Please make sure that you have thoroughly reviewed all applications and that the applications are in compliance with N.J.A.C. 2:76-6.20 prior to submitting the application to the SADC.

To help ensure that landowners clearly understand the provisions of the Deed of Easement, the SADC has instituted the use of guidance documents. To date we have created four guidance documents that must be reviewed with and acknowledged by the landowner. They pertain to Exception Areas, Division of Premises, Nonagricultural Uses and Special Occasion Events. Please take the time to review these in detail with landowners and include a copy of the signed documents in your application returned to the SADC.

Pursuant to N.J.A.C. 2:76-17.2, an "eligible farm" means a targeted farm that qualifies for grant funding by achieving an individual rank score that is equal to or greater than 70 percent of the county's average quality score of all farms granted preliminary approval by the SADC through the county planning incentive grant program within the previous three funding cycles, as determined by the SADC.

N.J.A.C. 2:76-17.9 (a) and 17.2 (County Planning Incentive Grant Program)

These standards are effective January 1, 2024 through December 31, 2024

- <<<< to decrease processing time, the SADC utilize the average quality scores adopted in 2021 or 2022
- N.J.A.C. 2:76-17.9 -7: any farm not meeting this standard may seek a waiver

Pursuant to Resolution FY2020R6(5) Farms that meet the following criteria will be delegated to the Executive Director for approval, subject to availability of funding:

- > All "Priority" farms have been selected; and
- > Meets the County's 70% average quality score; or
- > Is over 60% of the County's average farm size and has a density score of at least 8 points and all "Alternate" farms have been selected; or
- > Is a unique and valuable agricultural resource to the surrounding community where development poses a threat to existing investment in preservation, and it has a reasonable opportunity to remain agriculturally viable.
