

SADC Soil & Water Program Eligibility Request

This form is to request for SADC staff to determine your preserved farm's eligibility for the Soil & Water Cost-Share Program. The Soil & Water Program helps reimburse up to 50% of costs for implementing farm conservation practices, *as outlined in a farm conservation plan*, that help protect soil and water resources and improve viability for NJ's preserved farms. This form consists of 3 brief sections and should take approximately 5 minutes.
