Re: Right to Farm Act – Conflict Resolution Process

Dear Mr. Stevens:

On May 10, 2006, the Morris County Agriculture Development Board (Morris CADB) received a complaint from the Township of Mount Olive against your property alleging that rough-cut trees from other properties are being delivered to your property. The trees are then processed and sold.

The Morris CADB had reviewed the complaint at its May 11, 2006 meeting and decided that the activities in question, bringing rough-cut trees from other properties and processing them for sale, do not qualify for the protection of the Right to Farm Act, N.J.S.A. 4:1C-1 et seq.

On June 8, 2006, the Morris CADB memorialized its decision of May 11, 2006 via a formal vote and decided that the activities in question do not qualify for the protection of the Right to Farm Act, N.J.S.A. 4:1C-1 et seq. and are outside the purview of the Morris CADB. Accordingly, these activities remain under municipal jurisdiction.

Be advised that pursuant to N.J.A.C. 2:76-2.10 et seq., any person aggrieved by the decision of the CADB may appeal the decision to the State Agriculture Development Committee (SADC)
