**RESOLUTION** 

**RE:** Right to Farm, N.J.A.C. 2:76-2.2

Request for Site Specific Agricultural Management Practices

In the Matter of George J. Schaefer (d/b/a Jean's Honey, Inc.)

Block 72.02, lot 10; Township of Raritan, County of Hunterdon

WHEREAS:

On April 29, 2010, a Right to Farm ("RTF") Application for a Site Specific

Agricultural Management Practice determination was submitted to the Hunterdon County

Agriculture Development Board ("CADB"), by George Schaefer, owner of Jean's Honey,

Inc. (Block 72.02, Lot 10; Raritan Township), a farm that is operated as an apiary

operation. The RTF Application requested approval from the CADB for the following:

1) produce and sale of honey bees and queens; 2) extraction and bottling of honey; and,

3) sale of honey and honey products.

On May 4, 2010, the CADB, through its Administrator, wrote to the SADC and to

Raritan Township notifying them that the application had been filed.

At its May 13, 2010 meeting, the CADB discussed the application and determined

that Jean's Honey, Inc. was a commercial farm operation in accordance with N.J.A.C.

2:76-2.3. At its June 10, 2010 meeting, it was determined a site visit would be necessary

and a Right to Farm hearing was scheduled for July 8, 2010.

On June 18, 2010, the CADB conducted a site visit at the Jean's Honey, Inc.

property.

On May 18, 2010, the CADB, through its attorney, wrote to the Raritan Township

Land Use Enforcement Officer informing the Township of the Board's policy that he

applicant be granted the opportunity to appear before the Township on an expedited basis

in order to explain the applicant's position and to give the Township an opportunity to

review the application. The Raritan Township Board of Adjustment reviewed the

operation with the applicant on June 3, 2010. On July 9, 2010, a written submission from

the Township setting forth the results of that meeting were received by the CADB one

day following the CADB hearing.

Proof of formal notice and publication was submitted by the applicant to the

CADB on July 8, 2010. Formal notice of the hearings was published in the Hunterdon

County Democrat on June 24, 2010 and served via certified mail on all landowners

within 200 feet of the subject property. (App-1)

On July 8, 2010, the CADB held a public hearing.

George Schaefer appeared on behalf of Jean's Honey, Inc. No representative from

Raritan Township was present and no one appeared to object to the granting of the

application. Mr. Schaefer provided a brief history of his business and testified to the

following:

- 1. The farmer has conducted his apiary operation on the property for over 40 years, which includes maintaining and selling bees, as well as extraction and sale of honey and honey products.
  - 2. At any given time the farmer has between 5 and 7 bee colonies.
- 3. All colonies are located at least 25 feed from any public sidewalk, alley, street or road.
- 4. The apiary has an on-site adequate source of water which is no more than one-half mile from the apiary.
  - 5. All bee equipment and hives are in good condition.
  - 6. All colonies are kept in movable frame hives.
- 7. There are three (3) residences located within 300 feet of the apiary, one to the North, one to the South, and one to the West.
- 8. The residences to the North and South are buffered by a building on the North side of the apiary and a six foot high soil berm to the South side.
- 9. The residences to the West is screened by a series of trees and bushes.
  The farmer could not speak to the density of the vegetation.

The CADB discussed the matter and considered the submissions and testimony of

the applicant.

NOW, THEREFORE, BE IT RESOLVED THAT THE HUNTERDON COUNTY

AGRICLUTURE DEVELOPMENT BOARD MAKES THE FOLLOWING

FINDINGS OF FACT:

1. The property in question is known as Block 75.02, Lot 10 in the Township

of Raritan.

2. Jean's Honey, Inc. runs a commercial farming operation on in accordance

with N.J.A.C. 2:76-2.3(b) and is entitled to protection under the New Jersey Right-to-

Farm law.

3. The Township of Raritan issues a letter to the operator of Jean's Honey,

Inc. on May 4, 2009 indicating the Township had no records of issuing a permit for the

business on the farm and instructed the owner to remove all items associated with the

business and to apply for a permit if desired.

4. On June 29, 2010 Raritan Township issued another letter to the owner of the operation confirming the operation had been in existence prior to the 1979 Zoning Ordinance and that that non-conformity was entitled to remain and continue. However, it he would have to apply for a variance to "grandfather" his operation to be submitted within one year.

5. The activities of the business are all related to an Apiary operation which is an SADC approved Agricultural Management Practice pursuant to N.J.A.C. 2:76-2A.2.

## NOW, THEREFORE, BE IT RESOLVED BY THE HUNTERDON COUNTY AGRICULTURE DEVELOPMENT BOARD AS FOLLOWS:

A. The request for Site Specific Agricultural Management Practices determination submitted by Jean's Honey, Inc. is approved with conditions for the following activities as follows:

- 1) Conducting an apiary operation;
- 2) Producing and sale of honey bees and queen bees;
- 3) Extracting and bottling of honey and honey products; and,
- 4) Sale of honey, wax, and honey products.
- B. The above listed activities are consistent with apiary services, or are ancillary support services to an apiary operation and as such are permitted uses on the property under the Right to Farm Act.

C. This application is approved with the following conditions:

1) The operation must conform to all of the requirements from apiary

operations pursuant to N.J.A.C. 2:76-2A.2.

2) A six-foot high solid fence on hedge must be erected in order to

buffer the residence to the South, in accordance with N.J.A.C. 2:76-2A.2(e).

D. This determination shall be forwarded to the State Agricultural

Development Committee within thirty (30) days, pursuant to N.J.A.C. 2:76-2.3(e).

E. Any person aggrieved by this decision, may appeal to the State

Agricultural Development Committee within forty-five (45) days, pursuant to N.J.A.C.

2:76-2.3(f).
