

**RESOLUTION OF THE SOMERSET COUNTY  
AGRICULTURE DEVELOPMENT BOARD  
RECOMMENDING A SITE SPECIFIC AGRICULTURAL MANAGEMENT PRACTICE  
ON GALLUP FARM, BLOCK , LOTS , BLOCK , LOTS  
AND BLOCK , LOTS  
MONTGOMERY TOWNSHIP, SOMERSET COUNTY**

**WHEREAS**, pursuant to the Right to Farm Act, N.J.S.A. 4:1C-1, *et seq.* and the State Agriculture Development Committee regulations, N.J.A.C. 2:76-2.3, a commercial farm owner or operator may make a request to the County Agriculture Development Board (hereinafter "Board") to determine if his or her operation constitutes a generally accepted agricultural management practice; and

**WHEREAS**, Alec Gallup of \_\_\_\_\_ 'l in Montgomery Township Somerset County, made a request in writing to the Board for the development of a site-specific agriculture management practice (hereinafter, "AMP") for an Equine Berm; and

**WHEREAS**, pursuant to N.J.A.C. 2:76-2.3(c), the Board advised in writing the State Agriculture Development Committee and the municipality of Montgomery of this request; and

**WHEREAS**, pursuant to N.J.A.C. 2:76-2.3(b), the Board requested that Alec Gallup provide proof that his/her agricultural operation is a commercial farm as defined at N.J.S.A. 4:1-C-3 and N.J.A.C. 2:76-2.1; and

**WHEREAS**, Alec Gallup provided to the Board his/her commercial farm certification, including supporting documentation, attached hereto; and

**WHEREAS**, staff of the County Agriculture Development Board, the County Planning Division, the office of Somerset and Union Soil Conservation District, the federal Natural Resource Conservation Service, the State Agriculture Development Committee and a representative of the Equine Science Center at Rutgers University conducted a site inspection of the Gallup farm; and

**WHEREAS**, on, at its regular meeting in January, the SCADB was presented with the findings of the site inspection; and

**WHEREAS**, the Right to Farm Committee of the SCADB agreed to develop a site-specific AMP for the Gallup Farm after making a finding that based upon the materials presented by the applicant that the Farm meets the requirements of the "Right-To-Farm" Act to be eligible for consideration under it's protections, and

**WHEREAS**, the SCADB sought the assistance of Rutgers Cooperative Extension, the Somerset County soil conservation district, in the determination of generally accepted agriculture management practices and standards relating to this activity.

**NOW THEREFORE, BE IT RESOLVED**, that the SCADB hereby determines that the Equine Berm on the Gallup Farm constitutes a generally accepted agriculture management practice provided that the activity must conform to all relevant Federal and State statutes, rules, and regulations.

**BE IT FURTHER RESOLVED**, that the Board shall forward a copy of its written recommendation of the site-specific AMP to Alec Gallup, the SADC, the Township of Montgomery and any other individuals or organizations deemed appropriate by the Board within 30 days of the recommendation.
