NOTICE OF PUBLIC HEARING AND REQUEST FOR COMMENTS¹

IN THE MATTER OF THE PETITION OF NEUSTAR, INC., ON BEHALF OF THE NEW JERSEY TELECOMMUNICATIONS INDUSTRY, FOR APPROVAL OF NPA RELIEF PLAN FOR THE 609 NPA AND ELIMINATION OF PROTECTED CODES IN THE 856 NPA BPU DOCKET NO. TO13121166

PLEASE TAKE NOTICE that the Board will hold a public hearing on the NANPA petition on February 23, 2017 at the Board's Offices at 44 South Clinton Avenue, 1st Floor, Trenton, New Jersey, commencing at 10 AM EST. Any interested member of the public who wishes to make a statement or comment on this matter is invited to attend the public hearing.

On December 10, 2013, NeuStar, Inc., the North American Numbering Plan Administrator ("NANPA"), in its role as the neutral third-party area code relief planner for New Jersey under the North American Numbering Plan, and on behalf of the New Jersey telecommunications industry ("Industry"), petitioned the New Jersey Board of Public Utilities ("Board") to approve the Industry's consensus decision to recommend to the Board (1) adoption of an all-services distributed overlay as the preferred form of relief for the 609 numbering plan area ("NPA") and (2) the elimination of the protected codes in the 609 and 856 NPAs ("NANPA petition").

On October 20, 2016, NANPA formally advised the Board of its projected 609 NPA numbering resource exhaustion date by the third quarter of 2018, revised from its initial forecasted date of the fourth quarter of 2019. The projected date is accelerated because the number of assignable central office codes fell significantly and Industry demand for 609 NPA numbering resources increased. At this time, only 25 assignable codes remain.
