NJBPU LAUNCHES COMMUNITY CAMPAIGN **FOR 'CLEANPOWER CHOICE'**

Summit, Princeton, ACUA, Belmar, Maplewood, Montclair, Middlesex County and Rowan University Lead the Way toward Climate Change Solutions

(NEWARK, NJ)- The New Jersey Board of Public Utilities and its Office of Clean Energy recently announced the launch of the CleanPower Community Partnership Campaign. Building on the CleanPower Choice Coalition that was founded in 2006 to join business leaders, environmental advocates, elected officials and residents together with a common goal of utilizing clean energy technologies that reduce energy, save money and help protect the environment, CleanPower Community Partners will reach out to educate their constituents to raise awareness about climate change solutions, clean energy technologies and opportunities to sign-up for CleanPower Choice.

The New Jersey CleanPower Choice Program, a voluntary initiative that allows customers to invest in clean energy, is the first statewide program of its kind where multiple utilities and clean power marketers will participate in a joint effort with the state to give consumers access to the regional market for renewable energy. For as little as an additional \$6.00 a month beyond the cost for basic service delivered by one's local utility, the program allows residents to support the development of clean renewable sources of energy, such as solar, wind, low-impact hydro or landfill gas. Four options allow residents to choose from slightly different mixes of renewable energy resources. Residents are sent only one bill from their electric company, with the CleanPower purchase shown as a separate line on it.

Participating electric distribution companies include PSE&G; JCP&L; Atlantic City Electric; and Orange & Rockland while clean power suppliers include Green Mountain Energy; Community Energy; Sterling Planet; and Jersey-Atlantic Wind, LLC.

Community partners include Princeton, Montclair, Maplewood, Summit, Atlantic County Utility Authority, Middlesex County and Rowan University. Each of these communities and/or organizations has signed-on to promote the CleanPower Choice Program and enroll local residents or constituents.
