NOTICE OF FILING AND PUBLIC HEARINGS TO CUSTOMERS OF ATLANTIC CITY ELECTRIC COMPANY

In the Matter of the Verified Petition of Atlantic City Electric Company for Approval of a Voluntary Program for Plug-In Vehicle Charging (Amended Petition)

PLEASE TAKE NOTICE that, on or about December 17, 2019, Atlantic City Electric Company ("ACE" or "Company") filed an Amended Petition to establish a comprehensive, multi-year program for Plug-In Vehicle ("PIV") Charging Program ("PIV Program") ("2019 PIV Amended Petition") with the New Jersey Board of Public Utilities ("Board" or "BPU"). The Company proposes to spend approximately \$42.107 million for 13 different program offerings to reduce PIV range anxiety; to encourage environmental mobility options in public places; and incentivize athome and off-peak charging and energy use management through PIV-friendly rate designs and incentives for smart vehicle charger installations. The Company proposes to recover its costs for the PIV Program, as well as a return on those costs, through an addition to its rate base for the capital necessary for the establishment of the PIV Program. In addition, the Company is seeking to establish the PIV Program Regulatory Asset to recover its non-capital costs associated with the various program offerings. The specific details of the rate recovery proposed for PIV Program costs are set forth in the Company's Amended Petition and the accompanying Company testimonies. ACE proposed the establishment of seven new tariff Riders, Rider "RS-PIV", Rider "REVCP", Rider "CEVCP", Rider "PC-PIV", Rider "NUOPDCFC", Rider "CTCP", and Rider "PIV-Green," each to relate to one or more PIV Program offerings. The approximate impact of the proposed increase on a typical residential customer's monthly bill, subject to Board approval of the proposed Riders, is demonstrated in Table 1.

If the PIV Program is approved as proposed, the Company estimates that a typical residential customer using 679 kWh per month would see an increase in the customer's monthly bill of \$0.69 or 0.52%.

The Board has the statutory and regulatory authority to approve and establish these tariff classifications and charges at levels it finds just and reasonable. Therefore, the BPU may determine and establish these charges at levels other than those proposed by ACE.

The 2019 PIV Amended Petition was filed with the Board and copies were also served upon the New Jersey Division of Rate Counsel ("Rate Counsel"), who will represent the interests of ratepayers.
