Pursuant to the "Open Public Meetings Act", N.J.S.A. 10:4-6 et seq., the New Jersey Board of Public Utilities ("Board") hereby gives notice of a Public Meeting to discuss the following matter:

IN THE MATTER OF THE IMPLEMENTATION OF A2528/S2344 (N.J.S.A. 48:3-60.3) AND

President Robert M. Hanna will preside over a "legislative-type" hearing in this matter to be held on Monday, December 3, 2012, at 2 p.m. at the Board's office at 44 S. Clinton Avenue, Trenton, New Jersey, in the 1st Floor Board Room. The purpose of the hearing is to take comments on the implementation of A2528/S2344 (N.J.S.A. 48:3-60.3), and in particular Board staff's SBC Credit Program straw proposal, found at: <http://www.njcleanenergy.com/files/file/SBC%20Straw.pdf>.

[This meeting was originally scheduled for November 5, 2012, but was cancelled due to Hurricane Sandy; a notice to that effect was issued on November 2, 2012.]

Interested parties will be allowed a fixed amount of time to present their comments, after which the President may have some clarifying questions. The amount of time allotted will be determined by the President at the hearing.
