A. Docket No. QO21040695 – In the Matter of the Clean Energy Program Authorization of Commercial and Industrial Program Energy Efficiency Incentives Exceeding \$500,000 – Bristol-Myers Squibb.

The Board will consider whether to grant Bristol-Myers Squibb an incentive of \$819,301.66 through the Large Energy Users Program. The incentive would help fund the installation of energy conservation measures at four (4) different Bristol-Myers Squibb locations across New Jersey.

B. Docket No. QO21040696 – In the Matter of the Clean Energy Program Authorization of Commercial and Industrial Program Energy Efficiency Incentives Exceeding \$500,000 – Port Authority of New York and New Jersey.

The incentive would help fund the installation of energy conservation measures the Elizabeth Port Authority Marine Terminal in Port Elizabeth, New Jersey.
