- A.** Docket No. TO20090615 – In the Matter of the Petition of Xchange Telecom, LLC for Designation as an Eligible Telecommunications Carrier in the State of New Jersey.

*On September 24, 2020, Xchange Telecom, LLC filed a Petition with the New Jersey Board of Public Utilities requesting designation as an Eligible Telecommunications Carrier to provide Lifeline service to qualifying New Jersey consumers.*

- B.** Docket No. TO20100635 – In the Matter of the Petition of Q Link Wireless, LLC for Designation as an Eligible Telecommunications Carrier in the State of New Jersey.

*On October 5, 2020, Q Link Wireless, LLC filed a Petition with the New Jersey Board of Public Utilities requesting designation as an Eligible Telecommunications Carrier to provide Lifeline service to qualifying New Jersey consumers.*

### **5. WATER**

- A.** Docket Nos. BPU WR20110729 and OAL PUC 10966-20 – In the Matter of the Petition of SUEZ Water New Jersey, Inc. for Approval of an Increase in Rates for Water/Sewer Service and Other Tariff Changes.

*The Board will consider SUEZ Water New Jersey's petition for a water/wastewater rate increase. The Parties have executed a stipulation, which, if approved by the Board, will result in an overall increase of \$16,350,000, which is approximately 5.51% over SUEZ's current total sales revenues. The impact on individual customers will vary by Service Area. Customers of Service Area 1, who use 6,000 gallons of water per month, bills will increase from approximately \$49.50 per month to approximately \$55.70 per month, which is an increase of \$6.20 per month.*

- B.** Docket Nos. BPU WR20070490 and OAL PUC 09623-2020S – In the Matter of the Petition of Lake Lenape Water Company for Approval of an Increase in Rates for Service.

*The Board will consider an Initial Decision recommending that the Board adopt a stipulation of the parties. The stipulation agrees that Lake Lenape's rates be increased by 7.89% over current rates.*
