- A.** Docket No. ER21111206 – In the Matter of the Petition of Atlantic City Electric Company for Approval of Electric Base Rate Adjustments Pursuant to its Infrastructure Investment Program (11/2021).

*The Board will consider Atlantic City Electric Company's Infrastructure Investment Program rate roll-in filing. The parties have executed a stipulation, which if approved by the Board, will result in a monthly increase of \$0.22 to an average residential customer.*

- B.** Docket No. EO22020043 – In the Matter of the Petition of Cumberland County Improvement Authority for the Approval of the Extension of Electric Public Utility Facilities of Atlantic City Electric Company Pursuant to N.J.S.A. 48:2-27.

*The Board will consider designating a Presiding Commissioner for Cumberland County Improvement Authority's petition for the extension of electric public utility facilities of Atlantic City Electric Company (ACE) and rule on the Motion to Intervene filed by ACE.*

*The Board will consider New Jersey Natural Gas Company's filing to revise two (2) rate components of its Societal Benefits Charge. The parties have executed a stipulation, which if approved by the Board, will result in an annual decrease of \$3.30 to a typical residential customer.*

*The Board will consider Atlantic City Electric Company's PowerAhead Program rate roll-in filing. The parties have executed a stipulation, which if approved by the Board, will result in a monthly increase of \$0.10 to a typical residential customer.*

- F. Docket No. EM21121253 – In the Matter of the Petition of Atlantic City Electric Company for Approval of the Modification of Power Purchase Agreements with Chambers Cogeneration Limited Partnership and Logan Generating Company, L.P.

*The Board will consider Atlantic City Electric Company's request to modify its Power Purchase Agreements with the Chambers and Logan coal plants.*

*The Board will consider the joint request of Aqua New Jersey, Inc. and Aqua Water Holdings, Inc. seeking approval of a change of control of Aqua New Jersey and approval of an updated Affiliated Interest Agreement.*

- B.** Docket Nos. BPU WR21111220 and OAL PUC 10027-21 – In the Matter of New Jersey-American Water Company for Authorization to Change the Level of its Purchased Water Adjustment Clause and Purchased Wastewater Treatment Adjustment Clause.

*The Board will consider an Initial Decision addressing New Jersey-American Water Company's Purchased Water Adjustment Clause and its Purchased Wastewater (Sewerage) Treatment Adjustment Clause. Based upon the Stipulation, the bill for a typical water customer, using 5,400 gallons of water per month, will increase by \$0.20 per month for the PWAC. Wastewater bills for Ocean City customers using 17,000 gallons of water during the summer quarter, will decrease by \$1.75 per month; wastewater bills for Lakewood customers will decrease by \$1.30 per month; wastewater bills for Adelphia customers will decrease by \$0.17 per month.*
