*The Board will consider Rockland Electric Company's Solar Successor Incentive Program cost recovery filing. The parties have executed a stipulation, which if approved by the Board, will result in the establishment as a new component within the Company's Regional Greenhouse Gas Initiative Charge tariff for recovery of costs associated with the implementation of the Solar Successor Incentive Program. The annual impact to typical residential electric customers will be an increase of \$1.92.*

- F. Docket No. ER21121236 – In the Matter of the Petition of Atlantic City Electric Company Regarding the Initial Setting of the Regional Greenhouse Gas Initiative Recovery Charge Associated with the New Jersey Successor Solar Incentive ("Susi") Program.

*The Board will consider Atlantic City Electric Company's Solar Successor Incentive Program cost recovery filing. The parties have executed a stipulation, which if approved by the Board, will result in the establishment of a new component of the Company's Regional Greenhouse Gas Initiative Recovery Charge tariff for recovery of costs associated with the implementation of the Solar Successor Incentive Program. If approved, the typical residential customer will see an increase in their monthly bill of approximately \$0.26 or 0.19%.*

- G. Docket No. ER21050859 – In the Matter of the Petition of Public Service Electric and Gas Company for Approval of the Recovery of Associated Costs Related to the Community Solar Energy Pilot Program ("Pilot Program").

*The Board will consider Public Service Electric and Gas Company's Community Solar Energy Pilot Program cost recovery filing. The parties have executed a stipulation, which if approved by the Board, will result in an annual increase of \$0.12 to a typical residential electric customer.*
