- A. Docket No. EF02030185 – In the Matter of the Verified Petition of Jersey Central Power & Light Company for Authorization Pursuant to N.J.S.A. 48:3-7.2 for Approval to Participate in the FirstEnergy Corp. Intra System Money Pool – Amendment No. 12 to the Petition.

The Board will consider Jersey Central Power & Light Company's request to participate in the FirstEnergy Corp. Intra System Money Pool not to exceed \$750 million outstanding at any one time through December 31, 2028.

These matters involve potential violations under the Electric Discount and Energy Competition Act, N.J.S.A. 48:3-48 et seq., by ResCom Energy, LLC d/b/a NextVolt Energy ("ResCom"). The Board will consider a stipulation of settlement between ResCom and Board Staff resolving all issues concerning the alleged violations alleged. The Board will also consider Rescom's initial application to reapply for a new license.

The Board will consider Atlantic City Electric Company’s January 2025 petition to modify its Non-Utility Generation Charge and Societal Benefits Charge rates. The parties have executed a stipulation for final rates which, if approved by the Board, would result in no changes to customer bills.

The Board will consider Atlantic City Electric Company’s July 2025 Conservation Incentive Program rate filing. The parties executed a provisional stipulation which, if approved by the Board, would result in a \$1.01 decrease to the monthly bill of a residential customer using 643 kWh per month.

The stipulation, if approved by the Board, would result in an increase of \$6.77 in the average monthly bill of a residential customer using 649 kWh per month.

The parties executed a stipulation of settlement for provisional CIP rates which, if approved by the Board, would result in a decrease to the monthly bill of a typical residential heating customer of \$2.53.
