BY THE BOARD:

This Order memorializes action taken by the Board of Public Utilities (Board) at its August 22, 2007 Agenda Meeting.

The Board of Public Utilities' Customer On-Site Renewable Energy (CORE) program offers prescribed financial incentives to New Jersey ratepayers to encourage the installation of Class I renewable energy technologies. Eligible applicants may receive rebates for a portion of the cost of installing solar, wind or sustainable biomass at their site.

The Staff of the Office of Clean Energy (OCE) has reviewed the application of Parsippany Wastewater Treatment Plant for a monetary rebate in the amount of \$1,744,754 under the CORE Program. The CORE rebate application requests a rebate toward installation of a solar electric system at 1139 Edwards Road, Parsippany, New Jersey. The number assigned to this application by OCE is MM05097. The docket number for this matter is EO07080579. OCE finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

The Staff of the Office of Clean Energy (OCE) has reviewed the application of the City of Ocean City, Ocean City Sports and Civic Center, for a monetary rebate in the amount of \$208,260 under the CORE Program. The CORE rebate application requests a rebate toward installation of a solar electric system at 550 Boardwalk, Ocean City, NJ. The number assigned to this application by OCE is BPU-4388. The docket number for this matter is EO07080588. OCE finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

The Staff of the Office of Clean Energy (OCE) has reviewed the application of the City of Ocean City, Economic Programs Office, for a monetary rebate in the amount of \$175,205 under the CORE Program. The CORE rebate application requests a rebate toward installation of a solar electric system at 1000 Haven Avenue, Vehicle Maintenance Building, Ocean City, NJ.² The number assigned to this application by OCE is BPU-4279. The docket number for this matter is EO07080589. OCE finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

The Staff of the Office of Clean Energy (OCE) has reviewed the application of the Branchburg Township School District for a monetary rebate in the amount of \$163,844 under the CORE Program. The CORE rebate application requests a rebate toward installation of a solar electric system at the Branchburg Central Middle School, 240 Baird Road, Branchburg Township, NJ.
