BY THE BOARD:

On September 26, 2007 pursuant to N.J.S.A. 48:2-21 and N.J.A.C. 14:1-5.12, Gordon's Corner Water Company (Gordon's Corner or Petitioner), a public utility of the State of New Jersey subject to the jurisdiction of the Board of Public Utilities (Board), filed a petition seeking to increase and revise its rates and charges for water service amounting to \$961,463 or approximately 10.90%.


The Board transmitted this matter to the Office of Administrative Law for hearing. On October 25, 2007, the Board suspended the proposed increase in rates until February 29, 2008, pending a determination on the hearing on the justness and reasonableness of Petitioner's proposed rates.


In light of the fact that this proceeding is pending before the Office of Administrative Law, the Board HEREBY ORDERS pursuant to N.J.S.A. 48:2-21, that the proposed revisions in rates be and are hereby further suspended until June 30, 2008, unless the Board prior to that date makes a determination disposing of the petition.


