BY THE BOARD:

On September 28, 2007, Environmental Disposal Corp. (EDC or Petitioner), a public utility of the State of New Jersey subject to the jurisdiction of the Board of Public Utilities (Board), filed a petition pursuant to N.J.S.A. 48:2-21 and N.J.A.C. 14:1-5.12 seeking to increase and revise Petitioner's rates and charges for water service amounting to \$524,355 or approximately 9.79%.

The matter was transmitted to the Office of Administrative Law on October 9, 2007. On October 25, 2007, the Board suspended the proposed increase in rates until February 28, 2008, pending a determination on the hearing on the justness and reasonableness of Petitioner's proposed rates.

In light of the fact that this proceeding is pending before the Office of Administrative Law, the Board HEREBY ORDERS pursuant to N.J.S.A. 48:2-21, that the proposed revisions in rates be and are HEREBY FURTHER SUSPENDED until June 28, 2008, unless the Board prior to that date makes a determination disposing of the petition.
