The New Jersey Board of Public Utilities' SMARTSTART Buildings Program ("SSBP" or "SMARTSTART") offers financial incentives to New Jersey ratepayers to encourage the installation of energy efficient products and technologies. Eligible applicants may receive rebates for a portion of the cost for installing energy efficient technologies, such as prescriptive lighting, HVAC and water heating.

Staff has reviewed the applications of Needleman Management, Inc. for a monetary rebate in the amount of \$136,882.00 under the SSBP. These SMARTSTART rebate applications, docket number EO08010026, request a rebate toward installation of custom electric and gas equipment at 1040 N Kings Highway Cherry Hill, NJ. Staff finds that these applications are complete and fully conform to all Board eligibility requirements for a rebate commitment under this program.

Staff has reviewed the application of NFL Productions for a monetary rebate in the amount of \$69,300.00 under the SSBP. This SMARTSTART rebate application, docket number EO08080084, requests a rebate toward installation of electric chiller at One NFL Plaza Mount Laurel, NJ. Staff finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

Staff has reviewed the application of KPMG LLP for a monetary rebate in the amount of \$95,200.00 under the SSBP. This SMARTSTART rebate application, docket number EO08020085, requests a rebate toward installation of electric chiller at 51 Chestnut Ridge Road Montvale, NJ. Staff finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

Staff has reviewed the application of East Coast Warehouse for a monetary rebate in the amount of \$54,900.00 under the SSBP. This SMARTSTART rebate application, docket number EO08020086, requests a rebate toward installation of prescriptive lighting at 1140 Polaris Street Elizabeth, NJ. Staff finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

Staff has reviewed the application of Cardinal Health for a monetary rebate in the amount of \$56,259.00 under the SSBP. This SMARTSTART rebate application, docket number EO08020087, requests a rebate toward installation of custom electric at 1120 Commerce Blvd. Swedesboro, NJ. Staff finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

Staff has reviewed the application of Chelsea Property Group for a monetary rebate in the amount of \$178,758.00 under the SSBP. This SMARTSTART rebate application, docket number EO08020100, requests a rebate toward installation of electric unitary HVAC at 4001 Route 66 Tinton, NJ. Staff finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

Staff has reviewed the application of U.S. FoodServices, Inc. for a monetary rebate in the amount of \$229,617.00 under the SSBP. This SMARTSTART rebate application, docket number EO08020101, requests a rebate toward installation of custom electric equipment at 1051 Amboy Avenue Perth Amboy, NJ. Staff finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

Staff has reviewed the application of Supremo Foods for a monetary rebate in the amount of \$197,435.00 under the SSBP. The SMARTSTART rebate application, docket number EO08020114, requests a rebate toward installation of custom electric equipment at 97 Smith Street, Perth Amboy, NJ. Staff finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

Staff finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

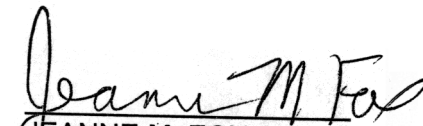

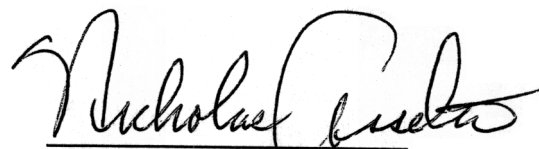

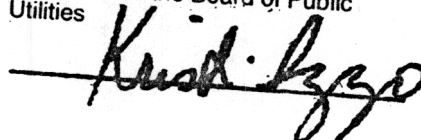
