BY THE BOARD:

On May 17, 2006, United Telephone Company of New Jersey, Inc., d/b/a Embarq filed a petition with the Board of Public Utilities (Board) to revise the title sheets of N.J.B.P.U. Tariffs No. 3 and No. 4 to d/b/a Embarq.

The petition is solely to change the title sheets of these two tariffs to properly reflect the company's current business structure. On August 26, 2005, United Telephone Company of New Jersey, Inc. d/b/a Sprint and LTD Holding Company filed a petition with the Board seeking approval of a change in ownership and control pursuant to N.J.S.A. 48:2-51.1 and N.J.S.A. 48:3-10. On March 9, 2006, the Board approved the transaction and ordered that the Petitioners notify the Board "of the consummation of the transaction within 5 days of its finalization." I/M/O United Telephone Company of New Jersey, Inc. d/b/a Sprint and LTD Holding Company for Approval Pursuant to N.J.S.A. 48:2-51.1 and N.J.S.A. 48:3-10 of a Change in Ownership and Control, BPU Docket. No. TM05080739. In a letter dated May 22, 2006, Petitioners notified the Board that the transaction had been finalized and that as of May 17, 2006 at 11:59 p.m. Petitioners became known as United Telephone d/b/a Embarq.


