BY THE BOARD:

On November 9, 2006, Embarq (Petitioner) filed a petition with the Board of Public Utilities (Board) to revise the terms and conditions of its Emergency Reporting Services provisions for the purpose of clarification.


The requested changes are being proposed in order to more closely align the tariff with the standard industry definitions as recommended by the National Emergency Number Association (NENA) and to better describe Embarq's Emergency Reporting Services offerings, which include 911 Enhanced Service, Wireless E911 Phase 2, and Reverse Notification Telephone Number Date Base Service. These revisions are non-rate affecting and do not affect how 911 Enhanced Service is provisioned by the company.

Accordingly, the Board, having reviewed the proposed revisions of the terms and conditions for Emergency Reporting Services, HEREBY FINDS that the filing is non-rate affecting and is in keeping with Embargo's responsibility to continue to provide safe, adequate and proper service at just and reasonable rates. For this reason, the Board HEREBY APPROVES this petition.






