BY THE BOARD:

By Order dated June 24, 2008, in this docket, the Board of Public Utilities authorized a three month extension of the nine month completion deadline for CORE program projects less than or equal to 10kW. For the reasons set forth in the June 24, 2008 Order, the Board ordered that "all CORE applicants that have received a commitment letter containing a completion deadline which falls within 2008, or those which receive a commitment letter within 2008, shall receive a three month extension of time, from nine months to twelve months, in which to complete their projects." The Renewable Energy Market Manager, Honeywell International, Inc., has requested a clarification of the Order to determine whether the Board intended to provide a three month extension from the date of the Board's Order or from a project's expiration date.

Upon review, the Board notes that a three month extension from the original expiration date could have resulted in a project that expired early in 2008 receiving a three month extension to a date which had already passed as of the Board's June 24, 2008 Order in this matter. For example, a project that expired on January 1, 2008 would have been extended until April 1, 2008. Therefore, the Board finds that it should clarify its June 24, 2008 Order.

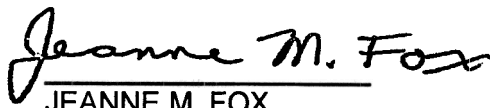
Accordingly, the Board **HEREBY CLARIFIES** its Order dated June 24, 2008 in this docket and **ORDERS** as follows:

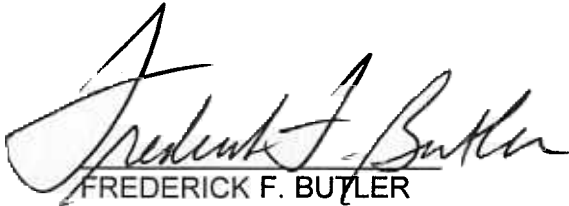
- 1 Any new commitment letters issued subsequent to the within Order in 2008 for projects less than or equal to 10kW shall indicate that the applicant has a total of 12 months from the approval date to complete the project consistent with existing CORE program policies.

2. Any commitment letters for projects less than or equal to 10kW heretofore issued in 2008 that provided only nine months to complete the project shall be revised to provide a three month extension, for a total of 12 months. The Renewable Energy Market Manager shall notify these projects of the new completion date.
3. Any project less than or equal to 10kW with a completion deadline that expired between January 1, 2008 and the date the within Order is signed shall have its deadline extended three months from the date this Order of Clarification is signed. The Renewable Energy Market Manager shall notify these project applicants of the new completion date.
4. Any project less than or equal to 10kW with a completion deadline which falls within 2008 after the date the within Order is signed shall have its expiration date extended by three months for a total of 12 months from the original approval date. The Renewable Energy Market Manager shall notify these project applicants of the extended completion date.

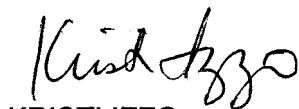
