BY THE BOARD:

The New Jersey Board of Public Utilities' SMARTSTART Buildings Program ("SSBP" or "SMARTSTART") offers financial incentives to New Jersey ratepayers to encourage the installation of energy efficient products and technologies. Eligible applicants may receive rebates for a portion of the cost for installing energy efficient technologies, such as prescriptive lighting, HVAC and water heating.

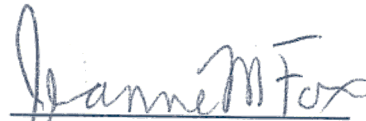
Staff has reviewed the application of Murphy's Atco for a monetary rebate in the amount of \$239,328 under the SSBP. This SMARTSTART rebate application, docket number EO09020129, requests a rebate towards installation of a high efficiency refrigeration equipment at 381 Medford Lakes Road, Vincetown, NJ. Staff finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

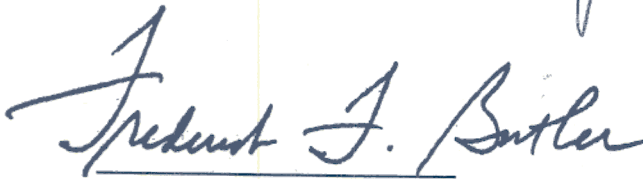

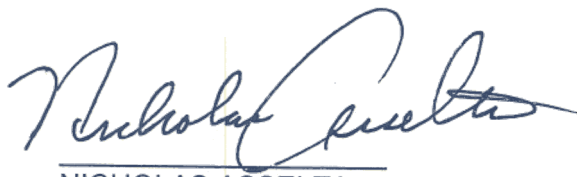

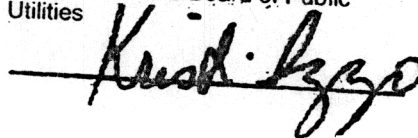
