#### BY THE BOARD:

On March 4, 2010, Dennis L. Usdin, on behalf of Zone Services LLC ("Petitioner"), filed a petition with the Board of Public Utilities ("Board") requesting a formal hearing related to a billing dispute with Public Service Electric and Gas Company ("Respondent") for utility services rendered by Respondent.

After the filing of Respondent's answer, the Board transmitted this matter to the Office of Administrative Law ("OAL") for hearing and initial disposition as a contested case pursuant to N.J.S.A. 52:14B-1 et seq. and N.J.S.A. 52:14F-1 et seq. This matter was assigned to Administrative Law Judge ("ALJ") Evelyn J. Marose.

While this matter was pending at the OAL, the parties engaged in negotiations and entered into and signed a Stipulation of Settlement ("Stipulation") that was submitted to the ALJ. By Initial Decision issued on September 9, 2010, and submitted to the Board on September 14, 2010, to which the Stipulation was attached and made part thereof, ALJ Marose found that the Stipulation was voluntary, that its terms fully disposed of all issues in controversy and that it satisfied the requirements of N.J.A.C. 1:1-19.1. Pursuant to the terms of the Stipulation, Respondent will credit Petitioner's account in the amount of \$8,314.76. Respondent will submit

a check to Petitioner in the amount of \$7,086.03, which represents the total credit of \$8, 314.76. less the outstanding balance on the account which is \$1,228.73.

After review of the record and the Stipulation of Settlement of the parties, the Board HEREBY FINDS that the parties have voluntarily agreed to the settlement as evidenced by their signatures and that by the terms of the Stipulation of Settlement, have fully resolved all outstanding contested issues in this matter.

Accordingly, the Board HEREBY ADOPTS the Initial Decision and the Stipulation of Settlement executed by the parties in their entirety as if fully set forth herein.

On May 17, 2010, the above referenced matter was transmitted to the Office of Administrative Law (OAL) for hearing as a contested case pursuant to N.J.S.A. 52:14B-1 to -15 and N.J.S.A. 52:14F1 to -13. A hearing was scheduled for August 9, 2010 and during that time, the parties notified the undersigned that the matter had been settled. A Stipulation of Settlement was signed by the parties and forwarded to the OAL on August 20, 2010 and is attached hereto and made a part hereof.
