BY THE BOARD:

The New Jersey Board of Public Utilities' (the "Board") SMARTSTART Buildings Program ("SSBP" or "SMARTSTART"), Direct Install Program and Pay-for Performance Program offer financial incentives to New Jersey property owners to encourage the installation of energy efficient products and technologies. Eligible applicants may receive incentives for a portion of the cost of installing energy efficient technologies such as lighting, HVAC, water heating or other measures in new or existing buildings.

Haglid Engineering & Associates, Inc. Edison, NJ has submitted an application for a monetary incentive in the amount of \$1,102,307 under the Pay-for-Performance program. This rebate application, Docket Number EO10050341, requests a rebate for the HVAC, Envelope and Lighting upgrades, and the Refrigeration Controls and Waste Heat Recovery System at 145 Talmage Road, Edison, NJ.

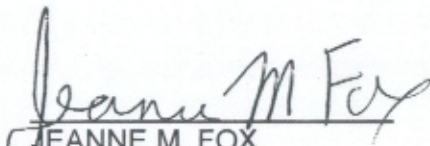
