BY THE BOARD<sup>1</sup>:

The New Jersey Board of Public Utilities’ (the “Board”) SMARTSTART Buildings Program (“SSBP” or “SMARTSTART”), Direct Install Program and Pay-for-Performance Program collectively offer financial incentives to New Jersey property owners to encourage the installation of energy efficient products and technologies. Eligible applicants may receive incentives for a portion of the cost of installing energy efficient technologies such as lighting, HVAC, water heating or other measures in new or existing buildings.

Joint Base MDL (McGuire AFB), 87 CES/CEAOE, McGuire AFB, NJ has submitted this application for a prescriptive lighting measure rebate in the monetary amount of \$417,573.00 under the SMARTSTART Buildings C&I Retrofit Program. This rebate application, Docket Number EO11040243V, requests a rebate for prescriptive lighting measures to be installed at 87 CES/CEAOE, McGuire AFB, NJ 08641.

TRC, the Market Manager engaged by the Board to manage the New Jersey Clean Energy Program C&I energy efficiency programs, has submitted a certification that the incentives for which TRC now seeks approval to commit have been calculated in accordance with the program policies and procedures, and that the listed amount is the true and accurate estimated incentive for which the applicant is eligible. Further, Applied Energy Group, in its role as the NJCEP Program Coordinator, has reviewed the application and submitted a certification that the incentive for which TRC now seeks approval to commit have been calculated in accordance with the program policies and procedures, and that the listed amount is the true and accurate estimated incentive for which the applicant is eligible. Based on the above, the Staff recommends that the Board approve the above referenced application.




