BACKGROUND

Pivotal Utility Holdings, Inc., d/b/a Elizabethtown Gas (" Company") has six former manufactured gas plant ("MGP") sites in New Jersey: two in Elizabeth, and one each in Rahway, Perth Amboy, Flemington and Newton. The Elizabeth, Rahway and Perth Amboy sites were solely owned and/or operated by the Company and/or its predecessor companies. Flemington and Newton were co-owned by a predecessor of the Jersey Central Power & Light Company ("JCP&L").

On October 23, 2015, the Company filed a petition ("2015 Filing") with the New Jersey Board of Public Utilities ("the Board") to revise the Remediation Adjustment Clause ("RAC") component of its Societal Benefits Charge ("SBC") rate.¹

In accordance with the Company's tariff, the RAC's rate is determined by calculating the sum of one-seventh of the Company's net deferred remediation costs incurred over the twelve months ended June 30, 2009 through 2015, less deferred tax benefits, and divided by projected normalized therm sales for the RAC year October 1, 2015 through September 30, 2016.

Leading up to 2015 Filing, in August 2014, the Company received an insurance recovery of \$42.75 million. Accordingly, one-seventh of this amount, \$6.1 million, will be credited to each of the remediation years 2015 through 2021.

¹ The 2015 Petition did not seek any adjustment of other SBC rate components, i.e. the New Jersey Clean Energy Program ("CEP"), Universal Service Fund ("USF") and Lifeline charges.

The 2015 Filing proposed a decrease to the Company's per therm RAC rate to a credit of \$0.0016 from the then current rate of \$0.0000, designed to refund \$0.7 million in RAC-related costs.

STIPULATION²

The Company, the Division of Rate Counsel ("Rate Counsel"), and Board Staff (collectively, "the Parties") engaged in extensive discovery, and on June 8, 2016 executed a stipulation of settlement ("Stipulation") intended to resolve all issues associated with this proceeding.

The key terms of the Stipulation are as follows:

- 1. The Company will implement a per therm SBC-RAC credit rate of \$0.0016.³ The calculation of this rate and the amount it is designed to refund are set forth in Appendices A and B attached to this Stipulation;
- 2. The Company represents that the labor allocation reflected in the RAC rate proposed in the 2015 Petition did not include recovery of incentive compensation costs, and the rates agreed to in the Stipulation do not reflect recovery of such costs;
- 3. The Company represents that the Company's filing does not include the recovery of any Natural Resource Damage related costs;
- 4. The Company agrees that it will include in future RAC filings responses to the minimum filing requirements ("MFRs") as set forth in Appendix C attached to the Stipulation, and that in future RAC filings it shall not request any late fees or late charges that are associated with legal costs recovered through the RAC;
- Upon approval by the Board of the SBC-RAC rate reflected in the Stipulation, the Company will propose and file with the Board a revised tariff sheet to reflect the SBC-RAC rate agreed to in the Stipulation. A draft tariff sheet is attached to the Stipulation as Appendix D;
- 6. The conditions reflected in paragraphs F, G and H of the Stipulation approved by the Board in Docket No. GR14101135, approving the Company's 2014 RAC proceeding concerning i.) competitive bidding, ii.) actual v. budgeted expenditures, and iii.) RAC audit reports, have been satisfied evidenced by the Company's GR15101210 "Minimum Filing Requirements" (numbered: 11, 17, and 7, respectively);
- 7. The current SBC per therm rate components, inclusive of all applicable taxes, not affected by this Stipulation include the CEP rate of \$0.0244 approved by the Board in BPU Docket No. GR15080866, the USF rate of \$0.0051 and the Lifeline rate of \$0.0057 approved by the Board in BPU Docket No. ER15060732. Approval of the RAC rate in this Stipulation will result in a total SBC rate of \$.00336; and
- 8. The annual bill impact of the stipulated RAC rate on a typical residential heating customer using 1,000 therms is a decrease of \$1.60, from \$847.73 to \$846.13, or 0.2%.

² Although summarized in this Order, the detailed terms of the Stipulation are controlling, subject to the findings and conclusions of this Order.

³ All rates herein include sales and use taxes.

DISCUSSION AND FINDING

The Board has carefully reviewed the record in this proceeding and the attached Stipulation. The Board FINDS that, with the terms and conditions set forth below, the Stipulation is reasonable and in accordance with the law, and demonstrates that the RAC costs have been thoroughly reviewed and found to be reasonable and prudent.

Accordingly, the Board HEREBY ADOPTS the Stipulation as its own, as if fully set forth herein, and HEREBY APPROVES the Company's implementation of a decrease in its SBC-RAC rate to a credit of \$ 0.0016 per therm and HEREBY DIRECTS the Company to file tariff sheets in the form attached as Appendix D to the Stipulation within five days of the effective date of this Order.

The Board HEREBY DIRECTS the Company to file tariff sheets in the form attached as Appendix D to the Stipulation with five days of the effective date of this Order.

The Company's gas costs will remain subject to audit by the Board. This Decision and Order shall not preclude the Board from taking any actions deemed to be appropriate as a result of any such audit.

The effective date of this Order is July 9, 2016.

BACKGROUND

- 1. On October 23, 2015, Pivotal Utility Holdings, Inc. d/b/a Elizabethtown Gas ("Elizabethtown" or "Company") filed a petition ("2015 Petition") with the New Jersey Board of Public Utilities ("BPU" or "Board") in BPU Docket No. GR15101210 to revise the Remediation Adjustment Clause ("RAC") component of its Societal Benefits Charge ("SBC") rate.
- 2. The 2015 Petition proposed a decrease to the Company's then current SBC-RAC rate of \$0.0000 per therm to (\$0.0016) per therm, inclusive of current sales taxes. The proposed SBC-RAC rate of (\$0.0016) per therm was designed to refund approximately \$0.7 million in RAC-related costs over a 12-month period. The 2015

Petition sought to reconcile Elizabethtown's RAC rate for the July 1, 2014 through June 30, 2015 period.

- 3. By Order dated June 18, 2015, issued in BPU Docket No. GR14101135 ("June 18 Order") the Board approved a Stipulation among Board Staff, the New Jersey Division of Rate Counsel ("Rate Counsel") and the Company resolving all issues concerning the petition to reconcile Elizabethtown's SBC-RAC, for the July 1, 2013 through June 30, 2014 period and approving the Company's currently effective SBC-RAC rate of \$0.0000 per therm inclusive of all applicable taxes.
- 4. The RAC-related costs for which recovery was sought in the 2015 Petition were the costs to test, contain and remediate the Company's former manufactured gas plant sites (described below) incurred during the period July 1, 2008 through June 30, 2015, based on a seven year cost amortization, plus certain adjustments and prior period true-up amounts. The 2015 costs totaled \$16,287,242 from which third party recoveries of \$42,750,000 were deducted and a net of \$388,661 for the deferral of 50% of litigation costs were added, resulting in proposed recoverable net remediation credits of (\$26,074,097) that are subject to refund over the seven-year period.
- 5. In accordance with the Company's tariff, the Company's original proposed SBC-RAC rider rate was determined by calculating the sum of (a) one seventh of its net deferred remediation costs incurred during the twelve months ended June 30th for the periods ending 2015, 2014, 2013, 2012, 2011, 2010 and 2009 totaling \$872,498, plus the deferred tax adjustment of \$104,696, the net of each year is shown in the table set out in

the footnote below, ¹ which equals \$977,194 (b) the prior year's RAC overrecovery balance of (\$1,470,436) and (c) (\$228,057) of interest accrued on RAC-related costs calculated in the manner approved by the Board in its order in BPU Docket No. GX99030121 and GO99030122 dated March 30, 2001. The sum of these amounts total (\$721,299) which was divided by the projected sales and service volumes to the service classifications subject to the RAC in order to yield the proposed SBC-RAC rider rate of (\$0.0016) per therm inclusive of all applicable taxes.

6. The Company has six former manufactured gas plant sites in New Jersey: two that are located in Elizabeth, one on South Street, and one on Erie Street including the Renora Landfill, and one each in Rahway, Perth Amboy, Flemington and Newton. The Erie Street, South Street, Rahway and Perth Amboy sites were owned and/or operated exclusively by Elizabethtown and/or its predecessor companies. Flemington and Newton were also owned by a predecessor of Jersey Central Power & Light, which is

The Company's 2015 Petition set forth the net deferred remediation costs for the twelve months ended June 30th for the period ending 2015, 2014, 2013, 2012, 2011, 2010 and 2009 less the deferred tax benefit as follows:

now owned by First Energy. The 2015 Petition sought recovery of costs for the Flemington and Newton sites attributable to Elizabethtown².

- 7. The 2015 Petition did not propose to adjust the New Jersey Clean Energy Program ("CEP"), Universal Service Fund ("USF") and Lifeline rate components of the SBC.
- 8. The 2015 Petition was not transmitted to the Office of Administrative Law by the Board and public hearings were not needed due to the rate reduction. Elizabethtown, Board Staff and Rate Counsel conducted discovery and discussed discovery-related issues and settlement of this proceeding.
- 9. Board Staff, Rate Counsel and Elizabethtown (the "Stipulating Parties") have reached this Stipulation which is intended to resolve all issues associated with the 2015 Petition in the manner set forth below.

STIPULATED MATTERS

The Stipulating Parties hereby STIPULATE AND AGREE as follows:

Effective Date

A. The Parties acknowledge that the RAC rate change will become effective as of the effective date of a Board Order approving this Stipulation in accordance with N.J.S.A. 48:2-40 or upon such date thereafter as the Board may specify.

Effective Rates

B. As of the Effective Date, Elizabethtown will implement an SBC-RAC rate of (\$0.0016) per therm, inclusive of all applicable taxes, and that rate shall remain in

² Recovery costs for the Flemington and Newton sites are shared between Jersey Central Power & Light ("JCP&L") and Elizabethtown Gas on a 60% / 40% basis, respectively, in accordance with Memorandum of Understanding between Elizabethtown and JCP&L dated February 23, 1993.

effect until changed by order of the Board. The calculation of this rate and the amount it is designed to refund are set forth in Appendices A and B, respectively, which are attached to this Stipulation.

- C. The Company represents that the labor allocation reflected in the SBC-RAC rate proposed in the 2015 Petition did not include recovery of incentive compensation costs and the rates agreed to in this Stipulation do not reflect recovery of such costs.
- D. The Company represents that the SBC-RAC filing does not include the recovery of any Natural Resource Damage ("NRD")-related costs. NRD-related costs are defined as compensation to the State of New Jersey for injury to its natural resources, above and beyond costs incurred to investigate, contain or remediate former manufactured gas plant sites. "NRD-related costs" also include any administrative, legal or consulting costs incurred by the Company associated with NRD claims being investigated by the New Jersey Department of Environmental Protection, as well as any amounts paid by the Company to resolve such claims. The parties accordingly stipulate and agree that the Board should make no determination in this proceeding as to the reasonableness, or the recoverability under the RAC component of the Company's SBC, of NRD-related costs, if any. The Parties expressly reserve their rights to argue their respective position on these and related issues in future proceedings, as appropriate and in a manner consistent with the Board's September 22, 2011 Order issued in BPU Docket Nos. GR07080645, GR08090836 and GR09080651 resolving Elizabethtown's 2007, 2008 and 2009 RAC proceedings.

- E. The Company agrees that it will include with its RAC filings responses to the minimum filing requirements ("MFR") as set forth in Appendix C to this Stipulation and that in future RAC filings it shall not request any late fees or late charges that are associated with legal costs recovered through the RAC.
- F. Upon approval by the Board of the SBC-RAC rate reflected in this Stipulation, the Company will propose and file with the Board a revised tariff sheet to reflect the SBC-RAC rate agreed to in this Stipulation. A draft tariff sheet is attached hereto as Appendix D.
- G. The current SBC rate components, inclusive of all applicable taxes, not affected by this Stipulation includes the CEP rate of \$0.0244 approved by the Board in BPU Docket No. GR15080866, the USF rate of \$0.0051 per therm and the Lifeline rate of \$0.0057 approved by the Board in BPU Docket No. ER15060732. Approval of the RAC rate in this Stipulation will result in a total SBC rate of \$0.0336 per therm, inclusive of all applicable taxes.
- H. The conditions reflected in paragraph F., G. and H. of the Stipulation approved by the Board in BPU Docket No. GR14101135 approving Elizabethtown's 2014 RAC proceeding have been satisfied as reflected in MFRs 11, 17 and 7, respectively, included with the 2015 Petition.

Rate Impact

I. The annual bill impact of the stipulated SBC-RAC rate of (\$0.0016) per therm on a typical residential heating customer using 1,000 therms is a decrease of \$1.60 from \$847.73 to \$846.13 or 0.2% as compared to the Company's rates effective February

1, 2016. The proposed rates will decrease Elizabethtown's annual revenues by approximately \$0.7 million based on the Company's most recent therm forecast.

All Issues Resolved

J. Upon the Board's approval of this Stipulation, all issues concerning the SBC-RAC and the costs recovered through this rate are deemed resolved for purposes of this proceeding, but remain subject to audit by the Board.

Further Provisions

- K. This Stipulation is intended to be accepted and approved in its entirety. In the event any particular aspect of this Stipulation is not accepted and approved in its entirety by the Board, then any Stipulating Party aggrieved thereby shall not be bound to proceed with this Stipulation and shall have the right to litigate all issues addressed herein to a conclusion. In the event this Stipulation is not adopted in its entirety by the Board in its Order in this matter, then any Stipulating Party hereto is free to pursue its then available legal remedies with respect to all issues addressed in this Stipulation, as though this Stipulation had not been signed.
- L. It is the intent of the Stipulating Parties that the provisions hereof be approved by the Board, as appropriate, as being in the public interest. The Stipulating Parties further agree that they consider this Stipulation to be binding on them for all purposes herein.
- M. It is specifically understood and agreed that this Stipulation represents a negotiated agreement and, except as otherwise expressly provided for herein, is intended to be binding only in this proceeding and only as to the matters specifically addressed herein.

WHEREFORE, the Stipulating Parties hereto do respectfully submit this Stipulation to the Board and request the Board to issue a Decision and Order approving this Stipulation in its entirety in accordance with the terms hereof.
