WITHDRAW FEATURE GROUP A SERVICE IN CERTAIN WIRE CENTERS IN NEW JERSEY

IN THE MATTER OF VERIZON NEW JERSEY'S

LETTER FILING FOR TARIFF REVISIONS TO

BY THE BOARD:

By letter dated January 28, 2019, Verizon New Jersey, Inc. ("Verizon" or "Company") filed a letter with the New Jersey Board of Public Utilities ("Board") to withdraw Feature Group A service in 39 wire centers in the State of New Jersey, which have undergone network transition from copper to fiber facilities. Alternative services are available over an upgraded all fiber-based platforms.

Feature Group A service provides access to the Company's network through a subscriber line connection rather than a trunk line. The service is primarily used for exchange access crossing State and/or a Local Access and Transport Areas ("LATAs"), and supports Verizon's initiative to update selective centers to the next-generation platforms and all-fiber facilities consistent with the rules established by the Federal Communications Commission ("FCC") in an order dated November 29, 2017<sup>1</sup>.

In the FCC Order, the FCC concluded that consumers are increasingly moving away from traditional telephone services provided over copper wires and towards next-generation technologies using a variety of transmission means, including copper, fiber, and wireless spectrum-based services. To that end, the FCC adopted a number of reforms aimed at removing unnecessary regulatory barriers to the deployment of next-generation networks by removing unnecessary impediments and streamlining the transition.

Verizon's filing indicates notification of the service withdrawal to its customers by mail (a copy of the customer letter was provided with the filing). In addition, the filing states that affected customers will receive an additional letter at least 90 days prior to service withdrawal. The letter gives customers time to make arrangements to either migrate to an alternative service offered by Verizon, or to other providers offering alternative services. Verizon will continue to withdraw Feature Group A service from other wire centers once fiber deployment is completed. Currently, there are 2 customers with Feature Group A in the disconnect centers that are yet to be completely built. Verizon represents that services will not be disconnected until work is completed and customers will be given 90 days' notice before the service is discontinued.

The New Jersey Division of Rate Counsel submitted comments by letter dated May 10, 2021, and stated that it does not oppose Board approval of the tariff revisions proposed by Verizon. **DISCUSSION AND FINDINGS** 

Accordingly, the Board FINDS that the proposed tariff changes are in the public interest. Therefore, after investigation, having considered the record submitted by Verizon, the Board HEREBY AUTHORIZES Verizon to effectuate the tariff changes proposed by Verizon.

The effective date of this Order is November 4, 2021.
