


BY THE BOARD:

Administrative Law Judge Tricia M. Caliguire's Initial Decision in this matter was received by the New Jersey Board of Public Utilities ("Board") on February 24, 2022. By previous Order of Extension, dated April 6, 2022, the period for issuing a Final Decision was extended to May 26, 2022. Prior to that date, and having received consent of all parties, the Board Staff requests an additional 45-day extension of time for issuing the Final Decision in order to adequately review the record in this matter.
