BY THE BOARD:³

By this Order, the New Jersey Board of Public Utilities (“Board”) considers a limited waiver of N.J.A.C. 14:8-11.4(b) to permit projects that received Permission to Operate (“PTO”) prior to the opening of the Administratively Determined Incentive (“ADI”) Program, or those that began construction prior to their acceptance into the ADI Program, eligibility for the ADI Program incentive. The Board also considers a limited waiver of N.J.A.C. 14:8-11.5(k), which forbids an increase in generation capacity by more than twenty percent (20%) or twenty-five (25) kWdc, whichever is smaller, over the size indicated in the registration accepted into the ADI Program.⁴

BACKGROUND

On July 9, 2021, Governor Murphy signed the Solar Act of 2021 ("Solar Act").⁵ The Solar Act directed the Board to establish a program to incent the development of at least 3,750 megawatts ("MW") of new solar by 2026.

On July 28, 2021, following an extensive stakeholder process, the Board approved the creation of the Successor Solar Incentive ("SuSI") Program, consisting of the ADI Program and the Competitive Solar Incentive Program.⁶ The ADI Program launched on August 28, 2021, and is open to residential projects, net metered non-residential projects equal to or less than five (5) MW, and community solar projects. The Board expressly limited ADI Program eligibility to projects that had not yet commenced construction, stating that "projects seeking eligibility in the ADI Program are required to submit a complete ADI Program registration package and receive a notice of conditional registration prior to beginning construction on the facility."⁷ The Board's ADI rules, N.J.A.C. 14:8-11.1 to -11.9 ("ADI Rules"), which took effect February 22, 2022, codify this prohibition and further prohibit solar generation facilities from registering in the ADI Program if they commenced commercial operation prior to the opening of the ADI Program registration portal.

The ADI Program shall only be open to new facilities that have not commenced commercial operation prior to the opening of the ADI Program registration portal . . . Additionally, facilities seeking eligibility in the ADI Program must submit a registration and receive a notice of conditional registration pursuant to N.J.A.C. 14:8-11.5(g) prior to beginning construction on the facility, unless the Board grants a waiver in response to a petition.

[N.J.A.C. 14:8-11.4(b).]

The ADI Rules also limit increases in project generating capacity after registration in the ADI Program to 20 percent or 25 kWdc, whichever is smaller.⁸ "Facilities shall not be permitted to increase their generating capacity by more than 20 percent or 25 kWdc, whichever is smaller." [N.J.A.C. 14:8-11.5(k).]

Pursuant to the ADI Rules, the Board makes an annual allocation of capacity to each market segment established in the ADI Program. N.J.A.C. 14:8-11.7. The annual allocation of capacity to market segments for Energy Year 2025 ("EY25"), which commenced on June 1, 2025, was updated by Order dated May 22, 2024.⁹ The Board allocated the EY24 residential net metered

market segment to have a total capacity of 200 MWdc.

On February 14, 2024, the Board issued an Order waiving the requirements that project be accepted into the ADI Program prior to commencing construction and that a project not commence construction prior to the launch of the ADI Program.¹⁰ In that Order, the Board stated that after the end of the Energy Year 2024 (May 31, 2024), the Board would expect to see a rationale for a waiver other than installer error, supply chain delays caused by COVID 19 and the confusion with requirements from the predecessor program.

PETITIONS

As of May 31, 2024, the Board had received 110 petitions from customers and developers, which collectively represent 381 projects that seek a waiver of the Board's rules to participate in the ADI Program.¹¹

Of these projects, 348 received PTO prior to the receipt of the notice of conditional registration, which necessarily entails having commenced construction prior to receipt. An additional thirteen (13) projects received PTO prior to ADI Program launch. For these 361 projects, petitioners seek a waiver of N.J.A.C. 14:8-11.4(b) in order to register in the ADI Program. Petitioners contended that they have invested in solar projects at their homes and businesses in good faith and should be allowed to participate in the ADI Program to receive an incentive. Some alleged that they relied on their installers for completion of program requirements and were failed by them. The installers continue to cite challenges caused by the COVID-19 pandemic along with confusion regarding the new procedures applicable to the ADI Program, as reasons for projects failing to meet the requirements of the ADI Rules.

There are also twenty (20) projects among the petitions that are seeking approval of solar electric generation facilities at a capacity that exceeds the size submitted in the initial registration package by more than twenty percent (20%). These petitions seek a waiver of the ADI rules at N.J.A.C. 14:8-11.5(k).

Pending direction from the Board, the ADI registration processing team will not move forward in processing the 381 projects.

DISCUSSION AND FINDINGS

A majority of the projects considered in this order commenced construction, as evidenced by receipt of PTO, without receiving notice of conditional registration. A few projects received PTO

prior to the opening of the ADI registration portal. The prohibition on registration after starting construction is designed to ensure that solar incentives go only to projects that need incentives. This provision also recognizes the structure of the ADI Program in blocks of available capacity. It is intended to ensure that, when confronted with the impending full subscription of an ADI Program MW block and the closure of a market segment to new registrations, developers will not rush to construct projects prior to registration in the hope that commencement of construction without a valid registration would lock in an incentive value.

These continue to be valid policy goals. Nonetheless, some flexibility in the application of this restriction is warranted, although the time for such flexibility is coming to an end. The solar incentive program changed twice within the space of three (3) years, and there has been some confusion regarding the requirements of the different programs. For instance, the MW caps included in the ADI Program did not previously exist. The Board has previously recognized the justification for some flexibility under these circumstances;¹² in the February 14 Order, the Board extended such flexibility to petitions filed, like those addressed in this Order, by the last day of Energy Year 2024.

The Board's rules state that "[i]n special cases and for good cause shown, the Board may . . . relax or permit deviations from these rules." N.J.A.C. 14:1-1.2(b). The rules go on to explain that "[t]he Board shall, in accordance with the general purpose and intent of the rules, waive section(s) of the rule if full compliance with the rule(s) would adversely affect the ratepayers of a utility or other regulated entity, the ability of said utility or other regulated entity to continue to render safe, adequate and proper service, or the interests of the general public." N.J.A.C. 14:1-1.2(b)(1).

In launching the SuSI Program, the Board sought to provide a smooth transition to that program for projects already under development. As part of that effort, the Board provided in the SuSI Program Order that although the ADI Program was generally limited to new projects that had not yet begun construction, developers could file a petition with the Board to allow them to participate. That provision is codified in the ADI rules at N.J.A.C. 14:8-11.4(b), which contemplate and permit waivers of this provision to be granted by the Board. Subsequently, in the October 2022, April 2023 and February 14 Orders, the Board allowed projects that had registered in the ADI Program and had commenced construction prior to being accepted into the program to be eligible for incentives. As a result of their non-compliance with the ADI rules, the 348 projects that commenced construction prior to acceptance into the ADI Program would be denied incentives

absent a waiver by the Board. The Board **FINDS** that waiving the applicable rule for these projects will avoid stranding them without any incentive. The Board **FINDS** that facilitating the ability of the petitioners' projects to similarly participate in the ADI Program will benefit the customers. The Board **FURTHER FINDS** that waiving N.J.A.C. 14:8-11.4(b) for a limited class of solar electric generation facilities seeking admission into the ADI Program that began construction prior to receipt of the ADI notice of conditional registration is in the public interest. The public benefits from a smoothly functioning incentive program and from smooth transitions between such programs. In circumstances such as those present here, a smooth transition is furthered by limited waivers of rules that would otherwise have the unintended consequence of stranding solar facilities without an incentive. Moreover, as noted above, the MW caps included in the ADI Program did not previously exist and in the past, registrations were not denied because of insufficient capacity to accommodate additional installations.¹³ The Board **FINDS** that some flexibility is appropriate at the present time. With respect to the customers that began construction prior to receipt of the ADI notice of conditional registration and petitioned for relief, the Board **GRANTS** these petitions, and having found good cause, **HEREBY WAIVES** the prohibition against commencing construction prior to receipt of the ADI Program notice of conditional registration enumerated in N.J.A.C. 14:8-11.4(b).

However, as was noted in the February 14 Order, solar market participants must adapt to the current incentive program and its requirements. The ADI Program launched on August 28, 2021, approximately two and a half years ago. The federal COVID-19 Public Health Emergency was lifted on May 11, 2023.¹⁴ Governor Murphy lifted the Public Health Emergency earlier still, on March 4, 2022.¹⁵ The Board observed that the end of EY24 served as an appropriate end point for waiving N.J.A.C. 14:8-11.4(b) without a rationale that goes beyond the launch of the ADI Program, COVID-19-related delays, or developer error. February 14 Order at 10.

The Board is aware that the petitions include a project that has received PTO but has not yet submitted a registration in the ADI Program.¹⁶ The Board **DIRECTS** the petitioner that sought a waiver for an unregistered project to register such project and provide the Project Number and associated name and address to the Program Manager within thirty (30) calendar days of the effective date of this Order. The Board also **DIRECTS** the petitioner to upload a copy of this Order with their registration.

Going forward, the Board may decline to consider a waiver request for a project that has not registered with the ADI Program.

With respect to the thirteen (13) projects that received PTO prior to the opening of the ADI registration portal and that petitioned the Board for a waiver of N.J.A.C. 14:8-11.4(b), the Board is cognizant that these projects achieved commercial operation during a time of novel challenges which affected many aspects of solar development. The Board closed one incentive program, opened and closed a second, and opened a third within the span of two (2) years. The Board **FINDS** that flexibility is warranted in this matter, and that deviation from the strict application of the rule provision is reasonable and appropriate. The Board **FINDS** that at this point in the progression of the Board's solar incentive programs, and under these specific circumstances, the non-compliance of these projects with the provisions of N.J.A.C. 14:11-4(b) prohibiting commercial operation prior to the opening of the ADI Program should not render them ineligible.

Therefore, having considered the petitions seeking a waiver of the prohibition on getting PTO prior to the opening of the ADI Program, the Board **GRANTS** these petitions, and having found good cause, **HEREBY WAIVES** the prohibition against commencing commercial operations prior to the opening of the ADI Program registration portal by the Board enumerated in N.J.A.C. 14:8-11.4(b) for the projects identified in this Order. The Board also recognizes that as a result of this waiver, these projects will benefit from an incentive for which they would not otherwise qualify. Thus, the Board **FURTHER FINDS** good cause, under these particular facts and circumstances, to modify the date on which the Solar Renewable Energy Certificate-II ("SREC-II") qualification life begins. Therefore, the Board **HEREBY WAIVES** N.J.A.C 14:8-11.6(a) to the extent necessary to permit the fifteen (15)-year SREC-II qualification life for these projects to commence on August 28, 2021, the first day of ADI Program registration opening, rather than on the date of commercial operation.

With respect to the twenty (20) projects seeking a waiver of the prohibition on exceeding their approved registration capacity by over twenty percent 20%, the Board notes that the rule governing size increases following registration has already been amended to raise the size of an allowable increase from ten percent (10%) to twenty percent (20%).¹⁷ The rule provision at issue is designed to ensure that project capacity aggregated across solar facilities within an ADI market segment does not exceed the amount of capacity allocated to that market segment by the Board.

Staff has noted that as of January 13, 2025, approximately 133 MWdc of the net-metered residential market segment capacity is subscribed.¹⁸ Although the capacity registered at this time does not approach the capacity cap allocated for EY25, the Board **FINDS** that this rate of registration means that this market segment could be fully subscribed before the end of EY25. The Board declines to further relax the application of this rule. The Board **FINDS** that there is no good cause to waive this rule and therefore **DENIES** these petitions.

The Board encourages these specific petitioners to withdraw their existing registrations and re-register their projects at their increased size.¹⁹ For any such project identified in this Order that re-registers, the Board **HEREBY WAIVES** the prohibition on commencing construction prior to acceptance at N.J.A.C. 14:8-11.4(b). The Board **DIRECTS** Staff to continue to monitor the rate at which capacity is registered in the ADI market segment.



The Board notes that the relief granted in this Order is predicated upon the specific facts and circumstances alleged by the petitioners. As noted above, the Board has found that as of May 31, 2024, requests for waiver of N.J.A.C. 14:8-11.4(b) require a rationale that goes beyond the impacts of COVID-19 and the programmatic changes of 2020-2021 if they are to be granted. Developers which continue to fail to comply with these rules will find themselves faced with the need to explain to their customers the reason that these customers will not receive the incentives available to them through the ADI Program at the time they registered.

The effective date of this Order is February 5, 2025.


