This matter is before the New Jersey Board of Public Utilities ("Board" or "BPU") concerning Board Staff's ("Staff") request for a forty-five (45)-day extension of time prior to the Board issuing a Final Decision in this matter.

On August 25, 2025, the Board received Administrative Law Judge Tama Hughes' Initial Decision in this matter, initiating a forty-five (45)-day statutory period for review and setting the date for final Board action as October 9, 2025.<sup>1</sup>
