BY THE BOARD:

On February 9, 2005, Karl F. Spatz (Petitioner) filed a petition with the Board disputing the bill of New Jersey American Water Company (Respondent) for water services.

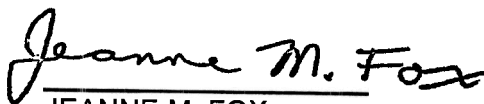
After the filing of Respondent's answer, the Board transmitted this matter to the Office of Administrative Law (OAL) for hearing and initial disposition as a contested case pursuant to N.J.S.A. 52:14B-1 et seq. and N.J.S.A. 52:14F-1 et seq. This matter was assigned to Administrative Law (ALJ) Judge Jeffrey A. Gerson.

While this matter was pending at the OAL, the parties engaged in negotiations and reached a settlement that was submitted to the ALJ. By Initial Decision issued on March 11, 2008, and submitted to the Board on March 18, 2008, to which the settlement was attached and made part thereof, ALJ Gerson found that the agreement was voluntary, that its terms fully disposed of all issues in controversy and that it met the requirements of N.J.A.C. 1:1-19.1. Pursuant to the terms of their settlement, the Petitioner has agreed to pay the amount of \$200.00 in 10 equal monthly payments of \$20.00. In return, the Respondent will credit the remaining balance due to the Petitioner's account.

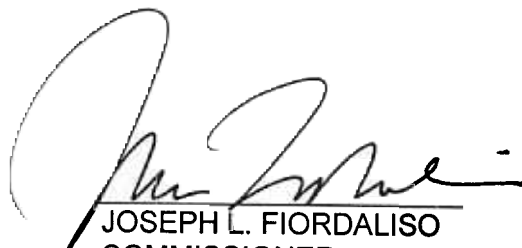
After a review and consideration of the Initial Decision and the agreement of the parties, the Board HEREBY FINDS that the terms of the agreement represent a fair and reasonable resolution of all outstanding contested issues. Accordingly, the Board HEREBY ADOPTS the Initial Decision and agreement of the parties in their entirety as if fully set out herein.

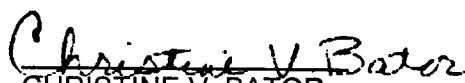

The parties have voluntarily agreed to the settlement as evidenced by the signatures of the parties or their representatives.

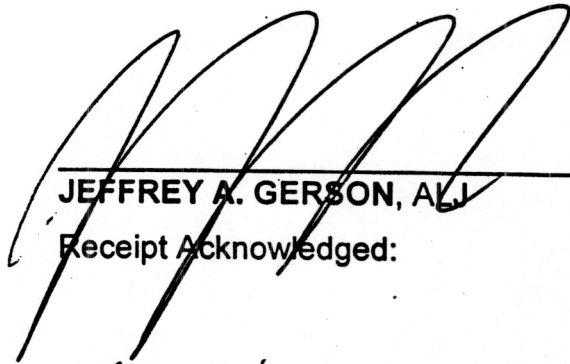
2. The settlement fully disposes issues in controversy and is consistent with law.

hereby FILE my initial decision with the BOARD OF PUBLIC UTILITIES for consideration.

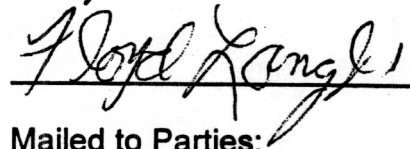
