BY THE BOARD:

On January 17, 2007, pursuant to N.J.S.A. 48:2-21, and N.J.A.C. 14:1-5.12, Petitioner, Fayson Lake Water Company (Fayson Lake), a public utility of the State of New Jersey subject to the jurisdiction of the Board of Public Utilities (Board) and serving approximately 881 customers within its defined service territory in Kinnelon Borough, Morris County, filed a petition for a revision of its rates, proposed to become effective on February 17, 2007. Petitioner seeks the requested increase to recover increased expenses, recovery of investments in its operating facilities and the opportunity to meet and earn a reasonable rate of return.

On January 26, 2007, the Board transmitted this matter to the Office of Administrative Law for hearing. By Order dated February 7, 2007, the Board suspended these proposed rates until June 17, 2007, pending a determination on the hearing on the justness and reasonableness of Petitioner's proposed rates.

In light of the fact that this proceeding is pending before the Office of Administrative Law, the Board <u>HEREBY ORDERS</u>, pursuant to <u>N.J.S.A.</u> 48:2-21, that the proposed revisions in rates be and are hereby Further Suspended until October 17, 2007, unless the Board prior to that date makes a determination disposing of the petition.
