BY THE BOARD:

On May 12, 2006, United Telephone Company of New Jersey, Inc., d/b/a Embarq (Petitioner or United) filed a petition with the Board of Public Utilities (Board) to clarify terms and conditions applied to Vanity Listings, on July 3, 2006 a revision was filed.

Embarq has requested to clarify its tariff for vanity listings to prevent the confusion that has occurred in some jurisdictions regarding whether or not a second monthly charge is to be applied if a subscriber has selected a vanity listing and wishes to have the numeric equivalent of that listing also shown. A second monthly charge is not required and Embarq seeks to make this clarification in its tariff. However, the customer will be charged the appropriate non-recurring charge for ordering processing if the numeric equivalent is added later by the customer.

Accordingly, the Board, having reviewed the terms and conditions of service, <u>HEREBY FINDS</u> that the proposed change clarifies the tariff and is in keeping with Embarq's responsibility to continue to provide safe, adequate and proper service at just and reasonable rates. For this reason, the Board <u>HEREBY APPROVES</u> this petition.
