Commissioners and employees should consult the agency ELO to discuss any particular holding that may not be reflected on this document, but may, nonetheless, be considered a prohibitive investment, financial interest, ownership, or any interest that would give rise to the appearance of a conflict of interest subject to divesture. This document may be revised from time to time at the discretion of the agency. Commissioners and employees are reminded of the ongoing duty to notify the agency ELO of any prohibited interests acquired at any time during the Commissioners and employees' engagement with the Board.
