On January 29, 2015, Cablevision converted its traditional municipal consent-based cable television franchise in Paterson into a SWF. Thereafter, on March 18, 2015, the Board issued a SWF to Cablevision for a term of seven (7) years, which expired on January 30, 2022. Cablevision currently only serves Paterson under its SWF, which is the subject of the Application.
