The Board issued subsequent renewals of the SWF on February 22, 2017, and March 19, 2025 (amended May 21, 2025) for a term of seven (7) years, to expire on January 10, 2031, which included the addition of seven municipalities to its SWF territory. Cablevision currently serves forty-three (43) municipalities under its SWF. On October 7, 2025, Cablevision filed an Application to add one (1) additional municipality to its franchise territory, the Township of Winfield, Union County, New Jersey.
