

NOTICE OF PUBLIC HEARING
In the Matter of the Application for Renewal of a
System-Wide Cable Television Franchise for Cablevision of
Newark, LLC
BPU Docket No. CE25060362

PLEASE TAKE NOTICE that, pursuant to the “Cable Television Act,” N.J.S.A. 48:5A-16(f), the New Jersey Board of Public Utilities (“NJBP” or “Board”) hereby gives notice of virtual public hearings to discuss the application of Cablevision of Newark, LLC (“Cablevision”) for a system-wide franchise (“SWF”).

Background

On May 11, 2010, Cablevision converted its traditional municipal consent-based cable television franchise in the Township of South Orange Village into a SWF. Thereafter, on August 4, 2010, in BPU Docket No. CE10050327, the Board issued a SWF to Cablevision for a term of seven (7) years. On March 18, 2015, also in BPU Docket No. CE10050327, Cablevision converted the City of Newark to its SWF during the term. On June 30, 2017, the Board issued a renewal SWF television franchise to Cablevision, for a term of seven (7) years which expired on May 11, 2024, in BPU Docket No. CE17030184. The Cablevision SWF currently contains the two (2) municipalities cited above. On June 17, 2025, Cablevision filed an application (“Application”) with the Board’s Office of Cable Television & Telecommunications, requesting the renewal of its SWF to continue offering cable television service.
