NOTICE OF PUBLIC COMMENT HEARINGS

PLEASE TAKE NOTICE that, on October 31, 2022, Atlantic City Electric Company ("ACE" or "Company") filed a petition with the New Jersey Board of Public Utilities ("Board" or "BPU"), which has been docketed as BPU Docket No. ER22100666, seeking the Board's approval of (i) a proposed infrastructure investment program entitled "Powering the Future," and (ii) a rate surcharge mechanism that will recover certain costs related to Powering the Future.

As proposed, Powering the Future seeks approval for \$379 million in investments to be made by the Company during a four-year period from 2023 to 2027. Powering the Future's infrastructure projects cover five categories: Targeted Reliability Improvements; Smart Technology Upgrades; Infrastructure Renewal; Solar/DER Enablement; and Substation Improvements. According to the Company, these projects will enhance distribution system reliability, resiliency, and safety, and facilitate deployment of distributed energy resources, renewables, and developing technologies.

If approved, Powering the Future will include a cost recovery mechanism ("Surcharge") that will result in an increase in distribution-related charges. The Company will set the Surcharge on a periodic basis coinciding with completion of, and initiation of service to customers by, Powering the Future investments. The Company estimates that the rate impact of the Surcharge will be an approximately 1% increase to the typical residential customer's bill per roll-in filing over the entire four-year life of the program. ACE estimates the total four-year cumulative impact on the monthly bill for a typical residential customer using approximately 680 kWh/month will be an increase of \$5.01, or approximately 3.55%, once Powering the Future is fully deployed.

The exact amount that your bill will increase depends upon the amount of electricity you use. Table #1 below details how the proposal would affect residential customers' bills, provided those customers take their electric supply from the Company and do not engage the services of a third-party supplier.

The Company does not seek to increase rates at this time but has filed an estimate of Powering the Future's potential rate impacts. Table #2 below details the Company's estimated rate impact upon full implementation of Powering the Future in 2027. Any final rate adjustments found by the Board to be just and reasonable may be modified and/or allocated by the Board in accordance with the provisions of N.J.S.A. 48:3-4, and for other good and legally sufficient reasons, to any class or classes of customers of the Company. Therefore, the described changes may increase or decrease based upon the Board's decision.

A copy of this Notice is being served upon the clerk, executive, or administrator of each municipality and county within the Company's service territory. The petition and this Notice have been posted on ACE's website at <u>www.atlanticcityelectric.com/PublicPostings</u> and have also been sent to the New Jersey Division of Rate Counsel ("Rate Counsel"), who will represent the interests of all ACE's customers in this proceeding.
