IN THE MATTER OF THE COMBINED AND CONSOLIDATED APPLICATION OF ATLANTIC CITY ELECTRIC COMPANY TO ADJUST THE LEVEL OF ITS "RIDER RGGI" CHARGES ASSOCIATED WITH ITS LEGACY SOLAR RENEWABLE ENERGY CERTIFICATE ("SREC I") FINANCING PROGRAM, ITS SUCCESSOR SOLAR RENEWABLE ENERGY CERTIFICATE ("SREC II") FINANCING PROGRAM, ITS SOLAR TRANSITION INCENTIVE ("TREC") PROGRAM, ITS SUCCESSOR SOLAR INCENTIVE ("SuSI") PROGRAM, ITS ENERGY EFFICIENCY ("EE") PROGRAM, AND ITS COMMUNITY SOLAR ENERGY PILOT ("CSEP") PROGRAM (2023)

PLEASE TAKE NOTICE that, on July 26, 2023, Atlantic City Electric Company ("ACE" or "Company") filed a petition with the New Jersey Board of Public Utilities ("Board" or "BPU") to reconcile, update, and approve certain proposed changes to the Company's Regional Greenhouse Gas Initiative ("RGGI") Recovery Charge Tariff for its Solar Renewable Energy Certificate ("SREC I" and "SREC II") Financing Programs, its Transition Renewable Energy Certificate ("TREC") Program, its Successor Solar Incentive ("SuSI") Program, its Energy Efficiency ("EE") Program, and its Community Solar Energy Pilot ("CSEP") Program ("Petition"). The SREC I and SREC II Programs are programs where ACE purchases SRECs from solar projects and sells the SRECs in an auction with other New Jersey electric distribution utilities ("EDCs"). The TREC Program is a statewide program established by the Board to provide incentives to solar developers in the form of TRECs. Under the TREC program, ACE and other New Jersey EDCs are required to acquire TRECs through a joint program administrator. The SuSI Program is a statewide program established by the Board to provide incentives to solar developers in the form of SREC IIs. Under the SuSI program ACE and other New Jersey EDCs are required to acquire SREC IIs through a joint program administrator. The EE program is a statewide program established by the Board pursuant to which the Company administers conservation programs, materials, and education to its customers. The CSEP program is a statewide program designed to facilitate access to solar energy on a community-wide basis for customers who are otherwise unable individually to participate in solar development programs or projects.

As proposed in the Petition, the Company seeks to decrease the tariff charge for its SREC I program from the current per kWh charge of (\$0.000121) to (\$0.000134) including Sales and Use Tax ("SUT"); maintain the tariff charge for the SREC II program at its current rate of \$0.000000 per kWh; increase the charge for its TREC program from the current per kWh charge of \$0.002423 to \$0.002701, including SUT; increase the charge for its SuSI program from the current per kWh charge of \$0.000059 to \$0.000216, including SUT; increase the charge for the EE program from the current charge of \$0.000840 to \$0.001679; and increase the charge for the CSEP program from the current charge of \$0.000000 to \$0.000022 for the period November 1, 2023 through October 31, 2024.

The SREC I component of the RGGI tariff is based upon actual costs and revenues through May 31, 2023, and projected data from June 1, 2023 through October 31, 2024. The effect of the change in the SREC I component for this period results in a \$1.079 million decrease to be returned to customers over the period November 1, 2023 through October 31, 2024. This results in a decrease in the SREC I charge from the current charge of (\$0.000121) to (\$0.000134) per kWh. For an

average residential customer using 680 kWh per month, this represents a monthly decrease of \$0.01 or 0.01 percent.

The SREC II component of the RGGI tariff is based upon actual costs and revenues through May 31, 2023, and projected data from June 1, 2023 through October 31, 2024. The effect of the change in the SREC II component for this period results in no change to the current charge of \$0.000000 per kWh for the period November 1, 2023 through October 31, 2024.

The TREC component of the RGGI tariff is based upon actual costs and revenues through May 31, 2023, and projected data from June 1, 2023 through October 31, 2024. The effect of the change in the TREC component for this period results in a revenue requirement of \$21.674 million to be recovered from customers over the period November 1, 2023 through October 31, 2024. This results in an increase in the TREC charge from the current charge of \$0.002423 to \$0.002701 per kWh. For an average residential customer using 680 kWh per month, this represents a monthly increase of \$0.19 or 0.13 percent.

The SuSI component of the RGGI tariff is based upon actual costs and revenues through May 31, 2023, and projected data from June 1, 2023 through October 31, 2024. The effect of the change in the SuSI component for this period results in a revenue requirement of \$1.731 million to be recovered from customers over the period November 1, 2023 through October 31, 2024. This results in an increase in the SuSI charge from the current charge of \$0.000059 to \$0.000216 per kWh. For an average residential customer using 680 kWh per month, this represents a monthly increase of \$0.11 or 0.07 percent.

The EE component of the RGGI tariff is based upon actual costs and revenues through May 31, 2023, and projected data from June 1, 2023 through June 31, 2024. The effect of the change in the EE component for this period results in a revenue requirement of \$13.476 million to be recovered from customers over the period November 1, 2023 through October 31, 2024. This results in an increase in the EE charge from the current charge of \$0.000840 to \$0.001679 per kWh. For an average residential customer using 680 kWh per month, this represents a monthly increase of \$0.57 or 0.39 percent.

The CSEP component of the RGGI tariff is based upon actual costs and revenues through May 31, 2023. The effect of the change in the CSEP component for this period results in a revenue requirement of \$0.176 million to be recovered from customers over the period November 1, 2023 through October 31, 2024. This results in an increase in the CSEP charge from the current charge of \$0.000000 to \$0.000022 per kWh. For an average residential customer using 680 kWh per month, this represents a monthly increase of \$0.02 or 0.01 percent.

The net effect of all proposed changes to the RGGI tariff components for the SREC I, SREC II, TREC, SuSI, EE, and CSEP charges is a combined annual increase of \$11.009 million. The following demonstrates the Company's proposed rate components applicable to all rate schedules, based upon actual data as of May 31, 2023, and projected data through October 31, 2024:

The effect of the changes in the SREC I, SREC II, TREC, SuSI, EE, and CSEP charges on the RGGI tariff for a typical residential customer's monthly electric bill using 680 kWh represents an increase of approximately \$0.87 or 0.59 percent. Residential customers using other monthly usage amounts, based on the Company's proposed rates, are illustrated below:

The percentage increases noted above are based upon a comparison with rates in effect as of July 1, 2023. The Board has statutory and regulatory authority to approve and establish rates it finds just and reasonable. Therefore, the Board may determine and establish these charges at levels other than those proposed by ACE.
