This fourth revision of the FY20 programs and budget is intended to align the NJCEP program fiscal year with the State fiscal year, which is extended to September 30, 2020.

Members of the public may file comments regardless of whether they participated in the public meetings. Comments may also be submitted electronically to [Board.Secretary@bpu.nj.gov](mailto:Board.Secretary@bpu.nj.gov) in PDF or Word format with the subject “Request for Comments - Proposed NJCEP Fiscal Year 2020 Fourth Budget Revision.” **Comments should be submitted by 5 p.m. ET on Thursday, August 27, 2020.**

Please note that these comments are considered “public documents” for purposes of the State’s Open Public Records Act. Stakeholders may identify information that they seek to keep confidential by submitting them in accordance with the confidentiality procedures set forth in N.J.A.C. 14:1-12.3.
