The annual BGS hearing in this docket will be held on September 11, 2020 from 10:00 a.m. – 3:00 p.m. Please note that in the interest of public health and safety, this meeting will be conducted remotely.

The purpose of the hearing is to take comments on the Electric Distribution Companies’ BGS proposal filed on July 1, 2020, as well as on any alternative BGS proposals filed by interested stakeholders. The hearing will be chaired by President Joseph L. Fiordaliso.

For those unfamiliar with the process, interested parties will be allowed a fixed amount of time to present comments, after which President Fiordaliso and Board Staff may have some clarifying questions. The amount of time allotted to each speaker will be determined by the President at the hearing.

Final Comments on the procurement proposals will be due on, Monday, October 5, 2020. Final Comments should only be used to respond to issues raised in the Initial Comments, issues raised at the Legislative-type hearing or questions issued by Board staff as part of this matter. They should not be used to raise new issues in this proceeding.


