NOTICE OF PUBLIC MEETING

IN THE MATTER OF THE ESTABLISHMENT OF PROGRAMMING FOR THE 2020-2022 RGGI STRATEGIC FUNDING PLAN

TAKE NOTICE that Staff of the New Jersey Board of Public Utilities (“NJBP” or “Board”) (“Staff”) hereby invites all interested parties and members of the public to participate in a virtual public meeting to discuss the opening of a second application (“Application”) period for the Regional Greenhouse Gas Initiative (“RGGI”) Medium- and Heavy-Duty (“MHD”) Electric Vehicle (“EV”) Charging Program established by the Board via Order dated October 26, 2022.¹ This will be a public information session about the RGGI MHD Charging Program and its Application process. Interested parties and members of the public will have the opportunity to ask questions.

By the October 2022 Order, the Board allocated \$16,150,648 in RGGI auction proceeds for MHD charging grants via the RGGI MHD EV Charging Program. By Notice of Fund Availability issued December 17, 2025, the Board announced \$10,195,648 in available funding for MHD charging deployment projects through a competitive application process that subsequently opened January 1, 2026. By updated NOFA issued May 21, 2026, the Board extended the application deadline to July 31, 2026, increased the available funding to \$10,375,648, and provided additional clarifications based on Applicant questions.

Eligible Applicants are businesses located or primarily operating in Overburdened Communities, as defined by New Jersey’s Environmental Justice Law.
