TO OUR CUSTOMERS:

PLEASE TAKE NOTICE that on June 3, 2022 Gordon's Corner Water Company (the "Company"), pursuant to N.J.S.A. 48:2-14 and N.J.A.C. 14:1-5.5, filed a Petition with the Board of Public Utilities of the State of New Jersey (the "Board"), seeking approval of a municipal consent by Colts Neck Township ("Township") granting the Company a limited franchise to provide water service to a certain area of Colts Neck Township ("Proposed Franchise Area").

Resolution No. 2021-172 was adopted by the Township on September 8, 2021, pursuant to N.J.S.A. 48:2-14, and N.J.S.A. 48:3-11 to 48:3-15, granting municipal consent to the Company for the limited expansion of its existing franchise area within neighboring municipalities into the Township to provide water service to the site of a new court-mandated multi-family development ("Project") located at Block 22, Lot 18 on the Official Tax Map of the Township.

NO INCREASE IN RATES WILL RESULT FROM THE PETITION. Gordon's Corner proposes to charge rates for water service according to its tariffs on file with the Board. Customers would only be subject to changes in rates if and when the Board approves any such modifications to those tariffs.
