

**NOTICE TO THE RESIDENTS OF PILESGROVE TOWNSHIP AND OTHER
INTERESTED PARTIES OF PUBLIC HEARING**

COMPANY, INC. FOR APPROVAL OF A MUNICIPAL CONSENT GRANTED BY
THE TOWNSHIP OF PILESGROVE, COUNTY OF SALEM**

PLEASE TAKE NOTICE that, on July 9, 2025, New Jersey-American Water Company, Inc. (“NJAWC” or “Company”) filed a petition (“Petition”) with the New Jersey Board of Public Utilities (“Board”) pursuant to N.J.S.A. 48:2-14, N.J.A.C. 14:1-5.5, and such other regulations and statutes as may be deemed applicable and appropriate by the Board, for approval of a municipal consent ordinance (“Ordinance 25-02”) granted to NJAWC by Pilesgrove Township (“Township”).

The Township adopted Ordinance 25-02 on March 11, 2025, pursuant to N.J.S.A. 48:3-11 through 48:3-15, N.J.S.A. 48:19-17 and N.J.S.A. 48:19-20, and N.J.S.A. 48:13-11, granting municipal consent to NJAWC to construct, lay, maintain and operate the necessary water mains, pipes and appurtenances throughout the Township and to provide water service to an approved development in portion of the Township identified as Block 45, Lots 1.01, 1.02, 1.03, 1.04 and 1.06 as shown on the Tax Map of the Township (“Proposed Franchise Area”).

NO INCREASE IN RATES WILL RESULT FROM APPROVAL OF THE PETITION. If the Petition is approved, NJAWC will implement the general metered service tariff rates under Rate Schedule A-1 in the Company’s Board approved tariff for the customers in the Proposed Franchise Area.

PLEASE TAKE FURTHER NOTICE that a virtual public hearing on the Petition has been scheduled for **October 9, 2025 at 10:00 a.m.**, which will be presided over by a hearing officer designated by the Board.
