

**NOTICE TO THE RESIDENTS OF MANSFIELD TOWNSHIP AND OTHER
INTERESTED PARTIES OF PUBLIC HEARING**

**IN THE MATTER OF THE PETITION OF NEW JERSEY-AMERICAN WATER
COMPANY, INC. FOR APPROVAL OF A MUNICIPAL CONSENT GRANTED BY
THE TOWNSHIP OF MANSFIELD, COUNTY OF WARREN**

PLEASE TAKE NOTICE that, on April 13, 2026, New Jersey-American Water Company, Inc. (“NJAWC” or “Company”) filed a petition (“Petition”) with the New Jersey Board of Public Utilities (“Board”) pursuant to N.J.S.A. 48:2-14, N.J.S.A. 48:3-11 to 15, N.J.S.A. 48:13-11, N.J.S.A. 48:19-20, N.J.A.C. 14:1-5.5, and such other regulations and statutes as may be deemed applicable and appropriate by the Board, for approval of a municipal consent ordinance (“Ordinance 2007-14”) granted to Applied Wastewater Management, Inc., which has since been acquired by NJAWC, by Mansfield Township (“Township”). The Township granted Ordinance 2007-14 in anticipation of the sale of assets owned by Landmark Companies, LLC to the Company.

The Township adopted Ordinance 2007-14 on December 26, 2007, pursuant to N.J.S.A. 48:3-11 to 15, N.J.S.A. 48:13-11, N.J.S.A. 48:19-17, and N.J.S.A. 48:19-20, granting municipal consent to the Company to lay its pipes, valves, pumps, manholes and other equipment and related facilities to extend, operate, and maintain sewer collection and treatment facilities to provide wastewater service to a portion of the Township commonly known as the “Meadows at Mansfield” consisting of the lands known and designated as Block 1501, Lot 9.01 as shown on the current tax map of the Township (“Proposed Franchise Area”) for a period of ninety-nine (99) years. NJAWC is the franchised water purveyor for the entire Township, including the Proposed Franchise Area.

NO INCREASE IN RATES WILL RESULT FROM APPROVAL OF THE PETITION. If the Petition is approved, NJAWC will implement the same charge as the rates paid by current Township wastewater customers pursuant to NJAWC Board approved Tariff, Rate Schedule 6-A.

PLEASE TAKE FURTHER NOTICE that a virtual public hearing on the Petition has been scheduled for **August 13, 2026 at 10:00 a.m.**, which will be presided over by a hearing officer designated by the Board. Members of the public are invited to listen to the hearing and express their views on the Petition by joining via video conference at the designated date and time using the following link or dial-in number:
