NOTICE TO MIDDLESEX WATER COMPANY CUSTOMERS

IN THE MATTER OF THE PETITION OF MIDDLESEX WATER COMPANY FOR APPROVAL OF PROPOSED COST RECOVERY OF LEAD SERVICE LINE REPLACEMENT PROGRAM

PLEASE TAKE NOTICE that, on May 15, 2023, Middlesex Water Company ("Company"), pursuant to P.L. 2021, c. 183, filed a petition ("Petition") with the New Jersey Board of Public Utilities ("Board"), for approval of the Company's proposed cost recovery for its plan to replace property-owner-side or customer-side lead service lines ("LSLs") and other related approvals.

As described in the Petition, buildings receiving water service from a water utility system are connected to that system through pipe commonly referred to as a "service line," which usually consists of two portions: a "company-owned" portion which connects to the water main owned by the Company (usually in the street) and a customer-owned portion connected to the building receiving water service. The customer-owned portion of the service line is owned and controlled by the owner of the building connected by the service line. Some of these service lines have been discovered to contain lead. P.L. 2021, c. 183 mandates a 10-year timeframe for the replacement by the water utility system of both portions of such service lines in New Jersey and provides that a plan should be implemented consistent with that law for cost recovery of customer-owned portion LSL replacement costs.

Under the Company's proposed cost recovery plan set forth in the Petition, the total estimated annual cost and the average monthly bill impact for an average residential customer with a 5/8" meter is set forth in the following table:
