FOR APPROVAL OF THE FOUNDATIONAL FILING RELATED TO DISTRIBUTION  
SYSTEM IMPROVEMENT CHARGE**

**TO OUR CUSTOMERS:**

PLEASE TAKE NOTICE that on April 7, 2026, Veolia Water New Jersey, Inc. (“Company”) filed a petition (“Petition”) with the New Jersey Board of Public Utilities (“Board” or “BPU”), seeking approval of a Foundational Filing to implement a Distribution System Improvement Charge (“DSIC”), pursuant to N.J.A.C. 14:9-10.1 et seq. A DSIC is a rate recovery mechanism to encourage, and support accelerated rehabilitation and replacement of certain non-revenue producing, critical water distribution components. Its purpose is to enhance safety, reliability, water quality, systems flows and pressure, and/or conservation. A DSIC rate is interim, subject to refund, until the subsequent base rate case.

The Company’s Petition consists of a Foundational Filing. The Foundational Filing lists the proposed projects from 2026 through 2030. If the Foundational Filing is approved, the Company will be required to file a base rate case within three years of the effective date of the Foundational Filing. Please note that the Company proposes to collect a maximum DSIC revenue requirement of \$20,993,861 annually. The Company will implement the DSIC surcharge if, and when, it achieves specific levels of infrastructure investment and completes and places the facilities into service as permitted by N.J.A.C. 14:9-10.1 et seq.

The Company has proposed that the monthly DSIC surcharge be assessed to the following services and classes of customers based on the customer’s meter size: General Metered Service. The maximum proposed rates shown below are expected to be assessed incrementally over a two-to-three-year period, commensurate with the Company’s actual DSIC program capital spending.

The customer impact during the DSIC Surcharge 2027–2030 period is reflected in the maximum proposed monthly DSIC rates contained in the Petition filed with the Board, as set forth below.

These proposed rates are estimates and may change; however, they will not exceed the amounts listed below. The maximum annual DSIC revenue requirement, \$20,993,861, cannot be exceeded.

\*Based on American Water Works Association flow rates. A 5/8" meter is equivalent to one unit, whereas a 1-inch meter is equivalent to 2.5 units based on the amount of water that will flow through the meter size.
