### IN THE MATTER OF THE BOARD'S REVIEW OF GENERIC BASIC GAS SUPPLY SERVICE ("BGSS") STRUCTURE AND PROCEDURES AND RELATED COMPETITION ISSUES Docket No. GO23020100

Pursuant to the "Open Public Meetings Act," N.J.S.A. 10:4-6, et seq., the New Jersey Board of Public Utilities ("NJBPU" or "Board") hereby gives notice of a virtual stakeholder meeting concerning the Board's review of the current Basic Gas Supply Service ("BGSS"). Due to the passage of time, the Board believes that it is appropriate to review the BGSS structure and procedures as well as related competition issues.
