d. Organizations which may apply for funding under this program: Each county through their County Youth Services Commission may apply for funding.

e. Qualifications needed by an applicant to be considered for funding: To be considered for funding, an eligible applicant must submit a completed CY 2016 Comprehensive Plan Update and CY 2016 Comprehensive Application, in accordance with the requirements of the program.

f. Procedures for eligible organizations to apply: Counties are to submit their CY 2016 Comprehensive County Plan Update and CY 2016 Comprehensive Application when applying for State Community Partnership Grant Program funds and Family Court Services funds. The Plan Update and Application will be mailed to each County Youth Services Commission Office simultaneously with the posting of this notice in the New Jersey Register. Applicants must complete and submit a Plan Update and Application by September 1, 2015. One original single-sided (with original signatures) and six copies of the Plan Update and Application must be submitted.

Proposed Amendments: Just and Reasonable Rates for Intrastate Inmate Calling Service (ICS)

Petitioners: Garden State Bar Association, Crystal Gibson, Sherin Makar, Lori Monteiro, the Prison Initiative Project of the Center for Action Research, the New Jersey Advocates for Immigrant Detainees, the New Jersey Institute for Social Justice, Pauline Ndzie, Jean Ross, and Rhonda Williams Whetstone.

Take notice that on April 30, 2014, the Board of Public Utilities (Board) received a petition from the Garden State Bar Association, Crystal Gibson, Sherin Makar, Lori Monteiro, the Prison Initiative Project of the Center for Action Research, the New Jersey Advocates for Immigrant Detainees, the New Jersey Institute for Social Justice, Pauline Ndzie, Jean Ross, and Rhonda Williams Whetstone, requesting that the Board "limit the rates, terms, and conditions imposed by intrastate ICS providers to 'just and reasonable rates', not to exceed \$0.05 per minute, for incarcerated people, detainees, and their families in both state and county prisons and jails." The petitioners also request that the Board hold regional public hearings to gather further public input.

The petitioners state that the Board should take into account the existence of technology and the rates available in other states when

setting just and reasonable rates that reflect the costs of providing phone services in New Jersey prisons and jails.

On May 2, 2014, Board staff contacted the petitioners by electronic mail seeking clarification on the relief being sought. On May 15, 2014, the petitioners filed an amendment clarifying that the petition should be considered a petition for rulemaking pursuant to N.J.A.C. 1:30-4.

In accordance with the provisions of N.J.A.C. 1:30-4.2, the Board mailed to the petitioners and filed with the Office of Administrative Law a notice of action on the petition. Notice of the Board's receipt of the petition was published in the June 16, 2014, issue of the New Jersey Register at 46 N.J.R. 1490(b).

Take further notice that the Board has considered this petition and the merits of the petitioners' requested new rules. Pursuant to N.J.A.C. 1:30-4.2, the Board determined the matter required further deliberation.

Take further notice that, on June 12, 2014, the petitioners consented by letter to extend the period for Board deliberation on the petition for rulemaking until October 31, 2014. On June 18, 2014, the Board agreed to the petitioner's request. See 46 N.J.R. 1722(a).

Take further notice that, on October 2, 2014, the petitioners consented by letter to extend the period for Board deliberation on the petition for rulemaking to January 31, 2015. On October 22, 2014, the Board agreed to the petitioners' request. See 46 N.J.R. 2288(c).

Take further notice that, on January 14, 2015, the petitioners consented by letter to extend the period for Board deliberation on the petition for rulemaking for 30 days to March 2, 2015. On January 21, 2015, the Board agreed to the petitioner's request.

Take notice that the New Jersey Cultural Trust, acting under the authority of Public Law 2000, c. 76 (N.J.S.A. 52:16A-72 et seq.) and the New Jersey Historical Commission, established by law in 1967 (N.J.S.A. 18A:73-21), hereby announce the availability of the following grant program:

Name of program: Fiscal Year 2016 New Jersey Cultural Trust Grants, administered by the New Jersey Historical Commission for Institutional and Financial Stabilization for History and Humanities Organizations.

Purpose: To both assist groups in addressing financial and operational challenges that threaten stability and to help build greater operational capacity to manage and advance the work and mission of the organization. Applicants must show that they have clearly identified the challenge or goal, and that the strategies and projects to address the challenge will produce significant and sustainable results. In this round, the New Jersey Historical Commission is encouraging proposals that enhance the organization's technological capability in an effort to reach a broad, diverse audience.

Eligible applicants: Must be a New Jersey incorporated, nonprofit history or humanities organization that is tax exempt under section 501(c)3 or 4 by determination of the Internal Revenue Service; registered with the Charities Registration Bureau; and **qualified by the Cultural Trust as of April 1, 2015.** In order to become qualified, an organization must also demonstrate that it fulfills an arts, history, or humanities mission through active programs and services, has been in operation for a minimum of four years, has a functioning board that provides financial oversight to the standards set by the Cultural Trust, and is tax-exempt.
