

NJ-CRC Extension Request Form

All fields are required unless otherwise indicated.

This Extension Request Form must be submitted at least 15 days before the relevant deadline. The Commission cannot extend a license if it has already expired and cannot extend a regulatory deadline once it has passed. Submission of an extension request does not guarantee that you will be granted an extension.

Attach any documents that support your reasons for requesting an extension in response to questions 15, 16, and 17. It is your responsibility to demonstrate why there is good cause for you to get an extension. Examples of acceptable documents include, but are not limited to:

- a copy of municipal resolution demonstrating local approval
- a copy of zoning approval letter
- an email or letter from a municipal official confirming that your application will be reviewed at an upcoming zoning board or planning board meeting on a specific date
- proof that you are actively trying to secure property (letters of intent, communication with property owner, draft lease agreement)
- confirmation email or confirmation page indicating that your local application has been submitted
- draft financial plan, change of ownership plan, construction plan, etc.
- any evidence of actions demonstrating you are making reasonable efforts towards becoming operational or compliant with a regulatory requirement.

By submitting this form, you are attesting that you have the legal authority to make decisions on behalf of the entity named in the form and that the information provided is truthful and accurate. Submission of false or misleading information may result in adverse action. Once the form is filled out, save the form and email it to CRC.Licensing@crc.nj.gov.
